**DETERMINATION OF SALARIES AND ALLOWANCES OF PROVINCIAL MINISTERS AND MEMBERS OF THE PROVINCIAL PARLIAMENT OF THE WESTERN CAPE**

Under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act 20 of 1998), I determine that the salaries and allowances of Provincial Ministers and Members of the Provincial Parliament of the Western Cape are the same as the upper limits of the relevant salaries and allowances determined by the President by Proclamation No. 52, 2008, published in *Government Gazette* No. 31597 of 12 November 2008, with effect from 1 April 2008.

Proclamation No. 17, 2007, published in *Provincial Gazette Extraordinary* 6484 of 30 November 2007, is hereby repealed.
