I, LYNNE BROWN, Premier of the Province of the Western Cape, under the powers vested in me by section 108(2) of the Constitution of the Republic of South Africa, 1996, read with section 18 of the Electoral Act, 1998 (Act 73 of 1998), and after consultation with the Electoral Commission, call an election for the Provincial Parliament of the Western Cape and set 22 April 2009 as the voting day.
