Interested persons are invited in terms of Section 9 of the Rental Housing Act, 1999 (Act No. 50 of 1999), to submit nominations for appointment by the Western Cape MEC for Housing to serve on the Western Cape Rental Housing Tribunal as:

1. Chairperson (Ref: RHT001)
2. Member (Ref: RHT002)

Functions of Tribunal

The core responsibilities of the Tribunal are to fulfil the duties imposed on it as contained in Chapter 4 of Act No. 50 of 1999. The Tribunal must receive, investigate, consider and make rulings on complaints regarding unfair rental housing practices which may unreasonably prejudice the rights of either party.

Composition of the Tribunal

In terms of Section 9 of Act No. 50 of 1999, the Tribunal will consist of not less than three and not more than five members, who are fit and proper persons. Nominations for the following vacancies are therefore called for the following positions:

Chairperson

Requirements: Must be suitably qualified and have the necessary expertise and exposure to rental housing matters. Specific Qualifying Requirement: An LLB or equivalent degree.

Members (including Alternate Members)

Requirements: People with expertise in consumer matters pertaining to rental housing or housing development matters and/or expertise in property management or housing development matters.

Submission of Nominations

Nominations must be submitted in writing and must contain at least the following information: Name, residential and postal addresses and contact number(s) of nominee AND an exposition of the reasons why the nominee is considered suitable to serve on the Tribunal.
