WESTERN CAPE PROVINCIAL TREASURY**GAZETTING OF ALLOCATIONS TO MUNICIPALITIES NOT LISTED IN THE DIVISION OF REVENUE BILL, 2010 (DOR BILL)**

I, Alan Winde, in my capacity as Provincial Minister of Finance, Economic Development and Tourism hereby publish the attached schedule in terms of section 29(2)(a) of the Division of Revenue Bill, 2010 (DOR Bill) which stipulates that the Provincial Treasury must on the same day that its budget is tabled in the provincial legislature or at a later date approved by National Treasury, but not later than 14 April 2010, publish, the following in the Gazette:

- I. the indicative allocation per municipality for every allocation to be made by the Province to municipalities from the Province's own funds;
- II. the envisaged division of these allocations contemplated in subparagraph (i) in respect of each municipality for the next financial year and the 2012/13 financial year; and
- III. the conditions and other information in respect of these allocations to facilitate performance measurement and the use of the required inputs and outputs.

This Gazette contains the municipal allocations as well as the per ward allocations of some conditional grants made to municipalities of certain provincial departments over the 2010/11 MTEF. The public release of this information, firstly, enables municipalities to effectively budget and implement programmes over a three-year budgeting cycle. Sources and levels of provincial funding are made predictable, certain and transparent for municipalities by their public disclosure. Secondly, the release of information assists the provincial and local spheres of government to align their spending priorities.
