**PROVINCIAL DEVELOPMENT COUNCIL**

THE PREMIER'S CALL FOR NOMINATIONS FOR APPOINTMENT AS MEMBERS OF THE PROVINCIAL DEVELOPMENT COUNCIL

WHEREAS the Provincial Development Council Repeal Bill was published for public comment by the Provincial Government on 9 December 2010; and

WHEREAS the term of appointment of the current members of the Provincial Development Council terminates on 13 May 2011; and

WHEREAS it is necessary to appoint new members for an interim period until finalisation of the legislative process,

NOW THEREFORE nominations (by any interested party) are hereby called for in terms of section 3(2)(b) of the Provincial Development Council Act, 1996 (Act 5 of 1996) for appointment to the Provincial Development Council.

- (1) The appointed members must represent:
  - (a) organised labour;
  - (b) civil society;
  - (c) organised business.
- (2) Every nomination must:
  - (a) state the nominator's reasons for the nomination;
  - (b) indicate which social partner (see (a), (b) or (c) in paragraph 1 above) it is intended the nominee (if appointed) will represent; and
  - (c) be accompanied by the nominee's CV and a signed declaration by the nominee of his or her willingness to serve on the Provincial Development Council.
- (3) Nominations must be made by no later than **16:00 on 17 May 2011**.

- (b) aandui watter maatskaplike vennoot (sien (a), (b) of (c) in paragraaf 1 hierbo) die benoemde (indien verkies) bedoel is om te verteenwoordig; en
- (c) vergesel wees van die benoemde se curriculum vitae en 'n ondertekende verklaring deur die benoemde van sy of haar bereidwilligheid om die Provinsiale Ontwikkelingsraad te dien.
