The Provincial Minister responsible for Education in the Western Cape, acting in terms of section 63(1)(cC) of the Western Cape Provincial School Education Act, 1997 (Act 12 of 1997), read with the National Curriculum Statement, 2011, (Government Gazette No. 34600 of 2011), intends to make the regulations set out in the following Schedule.

Definitions

1. In these regulations any word or expression to which a meaning has been assigned in the Act, has the same meaning assigned to it, and unless the context otherwise indicates,—

“**individual support plan**” means a plan designed for learners who need additional support or expanded opportunities, developed by educators in consultation with the parents and the Institutional-level Support Team;

“**teaching hours**” means the amount of allocated time during which instruction is given in subjects, as prescribed in the National Curriculum Statement; and

“**the Act**” means the Western Cape Provincial School Education Act, 1997 (Act 12 of 1997).

Minimum teaching hours per phase

2. The minimum teaching hours per school week and school day in public schools per subject per phase are the following:

(1) Foundation Phase (Grades R to 3):

- (a) The minimum teaching hours for Grades R, 1 and 2 is 23 hours per week, and for Grade 3 is 25 hours per week.

- (b) The minimum teaching hours per subject per week in the Foundation Phase are defined as follows:

- (c) (i) Ten hours are allocated to languages in Grades R to 2 and 11 hours in Grade 3.
- (ii) A maximum of 8 hours and a minimum of 7 hours are allocated to Home Language, and a minimum of 2 hours and a maximum of 3 hours to Additional Language in Grades 1 and 2.
- (iii) In Grade 3, a maximum of 8 hours and a minimum of 7 hours are allocated to Home Language, and a minimum of 3 hours and a maximum of 4 hours to First Additional Language.
- (2) Intermediate Phase (Grades 4 to 6):
- (a) The minimum teaching hours per subject in the Intermediate Phase is 27.5 hours per week.
- (b) The minimum teaching hours per subject per week in the Intermediate Phase are divided as follows:

(3) Senior Phase (Grades 7 – 9):

- (a) The minimum teaching hours in the Senior Phase is 27.5 hours per week.
- (b) The minimum teaching hours per subject per week in Senior Phase are divided as follows:

(4) Further Education and Training Phase (Grades 10 – 12):

- (a) The minimum teaching hours in the Further Education and Training Phase is 27.5 hours per week.
- (b) The minimum teaching hours per subject per week in the Further Education and Training Phase are divided as follows:

- (c) (i) The allocated time per week must be used only for the minimum required National Curriculum Statement subjects as specified above, and may not be used for any additional subjects added to the list of minimum subjects.
- (ii) Should a learner wish to offer additional subjects, additional time must be allocated for the offering of those subjects.

General principles

3. (1) The time allocated to breaks, assemblies and extramural activities is excluded from the minimum teaching time allocation.
- (2) Additional time must be allocated to support learners who experience barriers to learning.
- (3) Should the governing body of a school decide to close the school early on certain days of the week in response to religious observances, arrangements must be made to ensure that the minimum teaching hours per school week and school day is still adhered to.
- (4) In the case of a learner who, with permission of the principal, regularly misses part of the school day for specific reasons, arrangements must be made between the learner, his or her parents and the school management team to ensure that the learner's required teaching and learning, as per these regulations stays on track.

Individual support plans and minimum teaching hours

4. (1) The names of learners following individual support plans which deviate from the minimum teaching hours per school week per subject, and agreed to by the parents in writing, must be submitted by the principal to the District Director.
- (2) The District Director must be informed when such an individual support plan comes to an end and the learner follows the minimum teaching hours per week per subject with his or her peers.

Implementation dates

5. The implementation dates for the minimum teaching hours per school week and school day are as follows:
 - (1) Grades R, 1, 2, 3 and 10 – 1 January 2012.
 - (2) Grades 4, 5, 6 and 11 – 1 January 2013.
 - (3) Grades 7, 8, 9 and 12 – 1 January 2014.

Failure to comply

6. Any educator who, without just cause, fails to comply with these measures may be charged with misconduct, and disciplinary steps may be initiated against him or her as determined in the Employment of Educators Act, 1998 (Act 76 of 1998).

Title

7. These regulations are called the *Regulations Relating to the Minimum Teaching Hours per School Week and School Day in Public Schools in the Western Cape*.

Definisies

1. In hierdie regulasies het enige woord of uitdrukking waaraan 'n betekenis in die Wet geheg is, die betekenis aldus daaraan geheg en tensy uit die samehang anders blyk, beteken-

“**die Wet**” die Wes-Kaapse Provinsiale Wet op Skoolonderwys, 1997 (Wet 12 van 1997);

Minimum onderrigure per fase

2. Die minimum onderrigure per skoolweek en skooldag in openbare skole is per vak per fase is as volg:

 - (a) Die minimum onderrigure vir graad R, 1 en 2 is 23 uur per week, en vir graad 3 is dit 25 uur per week.

Algemene beginsels

3. (1) Die tyd wat toegeken word aan pouses, saalbyeenkomste en buitemuurse aktiwiteite is uitgesluit van die minimum onderrigtyd soos toegewys.
- (2) Addisionele tyd moet toegeken word om leerders te ondersteun wat leerhindernisse ervaar.
- (3) Indien die beheerliggaam van 'n skool besluit om die skool vroeg te sluit op sekere dae van die week ter wille van godsdienstige voorskrifte, moet reëlings getref word om te verseker dat skole die minimum getal onderrigure per skoolweek en skooldag steeds handhaaf.
- (4) In die geval waar 'n leerder, met die verlof van die prinsipaal, gereeld 'n deel van die skooldag om spesifieke redes misloop, moet reëlings getref word tussen die leerder, sy of haar ouers en die skoolbeheerspan.

Individuele ondersteuningsplanne en die minimum onderrigure

4. (1) Die name van leerders wat individuele ondersteuningsplanne volg wat afwyk van die minimum onderrigure per skoolweek per vak en waartoe skriftelik ooreengekom is met die ouers, moet deur die prinsipaal aan die Distriksdirekteur voorgelê word.
- (2) Die Distriksdirekteur moet ingelig word indien sodanige individuele ondersteuningsplan ten einde loop en die leerder weer die minimum getal onderrigure per week per vak saam met sy of haar portuurgroep volg.

Implementeringsdatums

5. Die implementeringsdatums vir die minimum onderrigure per skoolweek en skooldag is soos volg:
 - (1) Graad R, 1, 2, 3 en 10 – 1 Januarie 2012.
 - (2) Graad 4, 5, 6 en 11 – 1 Januarie 2013.
 - (3) Graad 7, 8, 9 en 12 – 1 Januarie 2014.

Versuim om te voldoen

6. Enige opvoeder wat, sonder rede, nie aan hierdie regulasies voldoen nie, kan van wangedrag aangekla word, en dissiplinêre stappe kan teen hom of haar ingestel word, soos bepaal in die Wet op die Indiensneming van Opvoeders, 1998 (Wet 76 van 1998).
