Owenza izilungiso kuMthetho weNtshona Koloni weArhente yoKhuthazo loTyalo-mali noRhwebo, 1996; ngenjongo zokwandisa iinjongo, amagunya kunye nomsebenzi we-Arhente yeNtshona Koloni yoKhuthazo loTyalo-mali noRhwebo namagunya nemisebenzi yabalawuli beBhodi yeArhente (iBhodi) kuquka nokukhuthaza ezokhenketho, osusa iinkcazo-magama ephelelwe lixesha kunye neemfuno ezingqamene namalungu eArhente, omisela igama lorhwebo lweArhente, owenza izilungiso kumgaqo-siseko weBhodi ngokususa abameli kumalungu eArhente nangokunika abamelia basuka kurhulumente wommandla, ofuna amaxwebhu afanelekileyo ezokhenketho namava abalawuli beBhodi, okunikela uMphathiswa amisele usihlalo okanye usekela-sihlalo weBhodi, ovuma isithuba seminyaka emithathu sokumiselwa kwamalungu eBhodi, ukunikela iBhodi imisele usihlalo weKomiti nganye yeBhodi, owenza izilungiso kwigama leArhente, oyekisa uMbutho wokuMaketha iNdawo yokuFikela, olungiselela utshitshiso lweWestern Cape Tourism Act, 2004, nolungiselela neminye imiba enxulumene nale.

1. IMVELAPHI

- 1.1 Imisebenzi enxulumene nokhuthazo lorhwebo, utyalo-mali nokhenketho kwiPhondo yensiwe ngamaziko azimeleyo kaRhulumente amabini, abizwa ngokuba nguMbutho wokuMaketha iNdawo yokuFikela emiselwe ngokwemiqathango yoMthetho iWestern Cape Tourism Act, 2004 (uMthetho 1 ka-2004) neArhente yeNtshona Koloni yoKhuthazo loTyalo-mali noRhwebo (Wesgro) emiselwe ngokwemiqathango yoMthetho weNtshona Koloni woKhuthazo loTyalo-mali noRhwebo, 1996 (uMthetho 3 ka-1996), (“uMthetho iWesgro”).
- 1.2 Ukuze kupunyezwe ucwangciso lwenkubo ehlanganisiweyo kukhuthazo lorhwebo kunye notyalo-mali nokhenketho kananjalo nonikezeloo lwenkonzo olusebenzayo, kufuneka inkqubo enye yokuhanjisa kweenkonzo nearhente. Oku kuzakuqinisekisa indlela epheleleyo kuhlobo lophuhliso loqoqosho oluquka urhwebo noshishino lokhenketho kwindawo ngendawo njengonobangela wokhuthazo loqoqosho. Inkqubo enye yokuhanjisa kweenkonzo izakuqinisekisa ukusetyenziswa okukuko kumaxabiso ezibonelelo zikarhulumente.
- 1.3 UMthetho iWesgro unika igunya elipheleleyo iWesgro kupuhhliso loqoqosho olunokwandisa lula ukuze luuke ukhuthazo lokhenketho. Ngenxa yoko kwensiwa izindululo kwizilungiso zomthetho ezifanelekileyo ukuze zandise imisebenzi yeWesgro kuquka ukhuthazo lokhenketho ukuze inike inkqubo enye yokuhanjisa kweenkonzo kukhuthazo lokhenketho,urhwebo notyalo-mali. Ukunika igunya elisemthethweni kwimibutho yokhenketho esekuhlaleni kuzakupheliswa njengoko ubonelelo ngemali nobume bale mibutho buququzelelwaa ngoomasipala.
- 1.4 Ukwandiswa kwemisebenzi yeWesgro ukuze yenze ukhuthazo lokhenketho kuvuma oku:
 - 1.4.1 ucwangciso lwenkubo ehlanganisiweyo ngokubhekiselele ekumaketheni iNtshona Koloni njengendawo yokhuthazo lorhwebo notyalo-mali nokhenketho; kananjalo
 - 1.4.2 nokuzinzisa inkqubo enye yokuhanjisa kweenkonzo ukukhuthaza urhwebo,utyalo-mali nokhenketho.
- 1.5 IWesgro yamkelwe ke ngoko njengezikko elifanelekileyo elisebenza njengenkubo enye yonikezeloo ngeenkonzo zokhuthazo lokhenketho, urhwebo notyalo-mali. IWesgro ke ngoko kufuneka isebeenze njengearhente yePhondo yonikezeloo ngophuhliso loqoqosho.
- 1.6 Ukuphuculwa kweWesgro yeyona nto ibalulekileyo kwaye njengenxalenye yoku, isicelo sokuba lilungu leWesgro sizakupheliswa. Ngoku iWesgro ayinawo amalungu. Amalungu eWesgro awanikwa mpatho ikhethekileyo kwabo bangengomalungu kwaye akukho nto ifunyanwayo ngokuba lilungu. Zonke iinkonzo,imisebenzi, ucweyo kunye neminye imisitho yeWesgro zinikezelwa simahla kubo bonke oosomashishini balapha eNtshona Koloni, ukuze kuzalisekiswe umbono weWesgro wokunceda lonke uphuhliso lwamashishini eNtshona Koloni.
