REGISTRATION AND LICENCE FEES FOR MOTOR VEHICLES REGULATIONS, 2013

The Provincial Minister of Transport and Public Works in the Western Cape, in terms of section 7 of the Western Cape Provincial Road Traffic Administration Act, 2012 (Act 6 of 2012), made the regulations set out in the Schedule.

SCHEDULE**Definitions**

1. In these regulations, any word or expression defined or used in the National Road Traffic Act, 1996 (Act 93 of 1996), or the regulations made under that Act, has the same meaning, unless the context indicates otherwise.

Registration and licence fees

2. The fees payable in respect of the registration and licensing of motor vehicles in the Province are as set out in the Annexure.

Repeal

3. The regulations published under Provincial Notice 94/2005 in Provincial Gazette 6235 dated 11 March 2005 are repealed.

Commencement

4. These regulations come into effect on 1 June 2013.

SCHEDULE**Definitions**

1. In these regulations, any word or expression defined in the National Road Traffic Act, 1996 (Act 93 of 1996), or the Western Cape Provincial Road Traffic Administration Act, 2012 (Act 6 of 2012), has the same meaning, and unless the context indicates otherwise—

“**cyclist**” means a person who rides or attempts to ride a pedal cycle;

“**National Regulations**” means the National Road Traffic Regulations, 2000;

“**pedal cycle lane**” means any area forming part of a public road which has been designated by the appropriate road traffic sign or road marking for the exclusive use of cyclists.

Duties of drivers of motor vehicles when passing cyclists

2. (1) The driver of a motor vehicle who passes a cyclist on a public road must—
- (a) exercise due care while passing the cyclist;
 - (b) leave a distance between the motor vehicle and the cyclist of at least one metre; and
 - (c) maintain that distance from the cyclist until safely clear of the cyclist.
- (2) Despite any solid barrier line or other road traffic sign prohibiting encroachment upon the right-hand side of the road, the driver of a motor vehicle on a public road may, where the roadway is not wide enough to comply with subregulation (1)(b) or (c) when passing a cyclist, encroach on that part of the road to his or her right, but only if—
- (a) it can be done without obstructing or endangering other persons or vehicles;
 - (b) it is safe to do so; and
 - (c) it can be done and is done for a period and distance not longer than is necessary to pass the cyclist.

Duties of cyclists

3. (1) When riding on a roadway, a cyclist must—
- (a) keep as close as possible to the left edge of the roadway;
 - (b) give conspicuous driving signals as contemplated in regulation 300 and Part II of Chapter X of the National Regulations; and
 - (c) stop in the circumstances contemplated in regulation 307 of the National Regulations.
- (2) A person may not ride a pedal cycle on a roadway—
- (a) on the right-hand side of a motor vehicle proceeding in the same direction, except when passing that motor vehicle or turning right at an intersection;
 - (b) abreast of another cyclist proceeding in the same direction, except when passing that cyclist;

- (c) while wearing a headset, headphones or any listening device other than a hearing aid; or
 - (d) while carrying another person on the pedal cycle, unless that pedal cycle is specifically equipped to carry more than one person.
- (3) A person may not ride a pedal cycle in the circumstances described in paragraph (2)(a) or (b) unless the person exercises due care while passing the motor vehicle or cyclist.

Lamps on pedal cycles

4. (1) A person may not ride a pedal cycle on a public road or pedal cycle lane during the period between sunset and sunrise unless—
- (a) the pedal cycle is fitted in the front with a head lamp capable of emitting a white light in accordance with regulations 158 and 178 of the National Regulations;
 - (b) the pedal cycle is fitted at the rear with a rear lamp capable of emitting a red light in accordance with regulations 158 and 178 of the National Regulations; and
 - (c) the head lamp and rear lamp are kept lighted.
- (2) A person may not ride a pedal cycle on a public road or pedal cycle lane at any other time when, due to insufficient light or unfavourable weather conditions, persons or vehicles on the public road or pedal cycle lane are not clearly discernible at a distance of 150 metres, unless the head lamp and rear lamp are kept lighted.

Offences and penalty

5. Any person who contravenes or fails to comply with any provision of these regulations commits an offence, and on conviction is liable to a fine, or to imprisonment for a period not exceeding one year.

Short title

6. These regulations are called the Safety of Cyclists Regulations, 2013.

Woordomskrywing

 - (b) ’n afstand van ten minste een meter tussen die motorvoertuig en die fietsryer laat; en
 - (c) daardie afstand vanaf die fietsryer handhaaf totdat hy of sy veilig verby die fietsryer is.

 - (a) ekunene kwesithuthi esiya kwicala aya kulo naye, ngaphandle kwaxa edlula kweso sithuthi okanye xa eza kujika ngasekunene;

- (b) amelane nomnye umqhubi-bhayisekile oya kwakwicala elinye naye ngaphandle kokuba uyamdlula loo mqhubi-bhayisekile;

- (2) Akukho mntu unokuqhuba ibhayisekile kwindlela kawonke-wonke nangaliphi na ixesha, ukuba kuthe ngenxa yokunqongophala kokukhanya okanye imozulu engentlanga, okanye xa abantu okanye izithuthi zingabonakali kakuhle kwisithuba seemitha ezili-150, ngaphandle kokuba izibane ezingaphambili nangemva zikhanyisiwe.
