**PROVINCIAL NOTICE****DEPARTMENT OF TRANSPORT AND PUBLIC WORKS****REGISTRATION AND LICENCE FEES FOR MOTOR VEHICLES REGULATIONS, 2014**

The Provincial Minister of Transport and Public Works in the Western Cape, in terms of section 7 of the Western Cape Provincial Road Traffic Administration Act, 2012 (Act 6 of 2012), has made the regulations set out in the Schedule.

**SCHEDULE****Definitions**

1. In these regulations, any word or expression defined or used in the National Road Traffic Act, 1996 (Act 93 of 1996), or the regulations made under that Act, has the same meaning, unless the context indicates otherwise.

**Registration and licence fees**

2. The fees payable in respect of the registration and licensing of motor vehicles in the Province are as set out in the Annexure.

**Repeal**

3. The regulations published under Provincial Notice 113/2013 in *Provincial Gazette* 7119 dated 18 April 2013 are repealed.

**Commencement**

4. These regulations come into effect on 1 July 2014.
