CALL FOR NOMINATIONS: WESTERN CAPE PROVINCIAL SAFETY ADVISORY COMMITTEE

The Minister of Community Safety (the Minister) may, in order to achieve the objectives of the Constitution of the Republic of South Africa and the Constitution of the Western Cape insofar as policing is concerned, exercise and perform the powers and functions as per Section 3 of the Western Cape Community Safety Act, 2013 (the Act). The Act also allows for the establishment of a **Provincial Safety Advisory Committee** to advise the Minister.

Members of the public and interested parties are invited to nominate candidates who would serve on the inaugural Provincial Safety Advisory Committee for a period of 3 years.

The role of the Provincial Safety Advisory Committee would be to report and make recommendations to the Provincial Minister of Community Safety at his request, with regard to –

- the functions of the Province in terms of Chapter 11 of the Constitution and Chapter 8 of the Constitution of the Western Cape, 1997;
- strategies, policies, budgets and annual performance plans in respect of the functions in terms of Chapter 11 of the Constitution and Chapter 8 of the Constitution of the Western Cape, 1997;
- regulations in terms of the Western Cape Community Safety Act which may be necessary; or
- any other matter arising from the application of the Act.

Composition of the Provincial Safety Advisory Committee

The Minister must appoint the members of the Committee after considering the names of fit and proper persons submitted by members of the public and interested parties. The Committee must consist of –

- a representative of the business community;
- a member of the judiciary, the Cape Bar or the Cape Law Society;
- a senior member of an academic institution with experience in the field of criminology;
- a representative from a non-governmental organisation involved in policing or related areas; and
- the Head of Department: Community Safety (*ex officio* member).

Remuneration as per the Minister of Finance (Adjustment of the remuneration levels for office bearers of certain statutory and other institutions) as at 1 April 2015:

- R3 784 per day as chairperson
- R2 296 per day as member
- travel allowances based on national tariffs of the Department of Transport.

Nominations must be submitted in the form of a letter signed by you providing your contact details and interest in policing/community safety, the name, surname and contact details of the nominee and motivation for your nomination of the candidate.

Also include a letter signed by the nominee accepting his/her nomination, a detailed CV with certified copies of qualifications and identity document or passport.

Failure to submit the required documents will result in the nomination not being considered unless valid reasons for such can be supplied.

OPROEP OM BENOEMINGS: WES-KAAPSE PROVINSIALE VEILIGHEIDSADVIESKOMITEE

Die Minister van Gemeenskapsveiligheid (die Minister) kan, ten einde die doelwitte van die Grondwet van die Republiek van Suid-Afrika en die Grondwet van die Wes-Kaap te bereik sover polisiëring betref, die magte en funksies uitoefen ingevolge Artikel 3 van die Wes-Kaapse Wet op Gemeenskapsveiligheid, 2013 (die Wet). Die Wet maak ook voorsiening vir die stigting van 'n **Provinsiale Veiligheidsadvieskomitee** om die Minister te adviseur.

Lede van die publiek en belangstellendes word uitgenooi om kandidate te benoem wat sal dien op die eerste Provinsiale Veiligheidsadvieskomitee vir 'n periode van drie jaar.

Die rol van die Provinsiale Veiligheidsadvieskomitee sal wees om op versoek van die Provinsiale Minister van Gemeenskapsveiligheid verslag te doen oor en aanbevelings te maak ten opsigte van –

- die funksies van die Provinsie ingevolge Hoofstuk 11 van die Grondwet en Hoofstuk 8 van die Grondwet van die Wes-Kaap, 1997;
- strategieë, beleide, begrotings en jaarlikse prestasieplanne ten opsigte van die funksies ingevolge Hoofstuk 11 van die Grondwet en Hoofstuk 8 van die Grondwet van die Wes-Kaap, 1997;
- regulasies wat ingevolge die Wes-Kaapse Wet op Gemeenskapsveiligheid nodig mag wees; of
- enige ander saak wat spruit uit die toepassing van die Wet.

Samestelling van die Provinsiale Veiligheidsadvieskomitee

Die Minister moet die lede van die Komitee aanstel nadat die name van bevoegde en geskikte persone wat deur lede van die publiek en belangstellende partye ingedien is, oorweeg is. Die Komitee moet bestaan uit –

- 'n verteenwoordiger van die besigheidsgemeenskap;
- 'n lid van die regbank, die Kaapse Balie of die Kaapse Wetsgenootskap;
- 'n senior lid van 'n akademiese instelling met ervaring op die gebied van kriminologie;
- 'n verteenwoordiger van 'n nieregeringsorganisasie betrokke by polisiëring of verwante terreine; en
- die Departementshoof: Gemeenskapsveiligheid (*ex officio*-lid).

Vergoeding soos volgens die Minister van Finansies (Wysiging van die vergoedingsvlakke vir ampsdraers van sekere statutêre en ander instellings) soos op 1 April 2015:

- R3 784 per dag as voorsitter
- R2 296 per dag as lid
- reistoelae gebaseer op nasionale tariewe van die Departement van Vervoer.

Benoemings moet ingedien word in die vorm van 'n brief wat deur u onderteken is en u kontakbesonderhede en belang in polisiëring/gemeenskapsveiligheid, die naam, van en kontakbesonderhede van die benoemde persoon en motivering vir u benoeming van die kandidaat insluit.

Sluit ook 'n brief wat deur die benoemde persoon onderteken is as aanvaarding van sy/haar benoeming en 'n gedetailleerde CV met gewaarmerkte afskrifte van kwalifikasies en identiteitsdokument of paspoort in.

Indien die vereiste dokumentasie nie ingedien word nie, sal die benoeming nie oorweeg word nie, tensy geldige redes verstrekkend kan word waarom die dokumentasie nie ingedien kon word nie.

- imimiselo yMthetho iWestern Cape Community Safety Act engaba yimfuneko; okanye
- nawuphi na omnye umba ovuka ngenxa yokusetyenziswa nokulandelwa koMthetho.

- ilungu leejaji zelizwe jikelele, i-Cape Bar okanye i-Cape Law Society;

- ummeli ovela kumbutho ongekho phantsi korhulumente obandakanyekayo kwezokupolisa okanye iingqingi ezichaphazelekayo; kunye
- neNtloko yeSebe lezoThutho neMisebenzi yoLuntu (ilungu ngenxa yesikhundla elisibambileyo).
