ACT

To appropriate additional adjusted amounts of money from the Provincial Revenue Fund in respect of funds that have become available for the requirements of the Province of the Western Cape in respect of the 2015/16 financial year; and to provide for matters incidental thereto.

WHEREAS the National Treasury has allocated additional funds to the Province in respect of the national conditional grant: Education Infrastructure Grant;

AND WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustments budget in the Provincial Parliament in respect of funds that have become available;

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province,

BE IT THEREFORE ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2015 (Act 2 of 2015), has the meaning assigned to it in that Act. 5

Appropriation of adjusted amounts of money for requirements of Province

2. (1) Adjusted appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2015/16 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedule. 10

(2) The spending of the appropriations contemplated in subsection (1) is subject to the Public Finance Management Act.

Amounts listed as specifically and exclusively appropriated

3. The amounts in respect of the national conditional grants listed in the Schedule as specifically and exclusively appropriated may be used only for the purpose stipulated in the Division of Revenue Act and in accordance with the framework published in terms of that Act. 15

Short title

4. This Act is called the Western Cape Additional Adjustments Appropriation Act (2015/16 Financial Year), 2016. 20

Tot bewilliging van bykomende aangesuiwerde bedrae geld uit die Provinsiale Inkomstefonds ten opsigte van fondse wat beskikbaar geword het vir die behoeftes van die Provinsie Wes-Kaap ten opsigte van die 2015/16-boekjaar; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

AANGESIEN die Nasionale Tesourie bykomende fondse aan die Provinsie toegeken het ten opsigte van die nasionale voorwaardelike toekenning: Toekenning vir Onderwysinfrastruktuur;

EN AANGESIEN artikel 31 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), bepaal dat die Provinsiale Minister verantwoordelik vir finansies 'n aansuiweringsbegroting in die Provinsiale Parlement ter tafel kan lê ten opsigte van fondse wat beskikbaar geword het;

EN AANGESIEN artikel 26 van die Wet op Openbare Finansiële Bestuur, 1999, bepaal dat die Provinsiale Parlement vir elke boekjaar geld moet bewillig vir die behoeftes van die Provinsie,

WORD DAAR DERHALWE BEPAAL deur die Provinsiale Parlement van die Wes-Kaap, soos volg:—

Interpretasie

1. In hierdie Wet, tensy dit uit die samehang anders blyk, het enige woord of uitdrukking waaraan 'n betekenis geheg is in die Wes-Kaapse Begrotingswet, 2015 (Wet 2 van 2015), die betekenis daaraan geheg in daardie Wet. 5

Bewilliging van aangesuiwerde bedrae geld vir behoeftes van Provinsie

2. (1) Aangesuiwerde bewilligings deur die Provinsiale Parlement van geld uit die Provinsiale Inkomstefonds vir die behoeftes van die Provinsie in die 2015/16-boekjaar, vir begrotingsposte en hoofindelings binne 'n begrotingspos, en vir die spesifieke doeleindes gelys, word in die Bylae uiteengesit. 10

(2) Die besteding van die bewilligings beoog in subartikel (1) is onderhewig aan die Wet op Openbare Finansiële Bestuur.

Bedrae aangedui as spesifiek en uitsluitlik bewillig

3. Die bedrae ten opsigte van die nasionale voorwaardelike toekennings in die Bylae aangedui as spesifiek en uitsluitlik bewillig, kan gebruik word slegs vir die doel bepaal in die "Division of Revenue Act" en ooreenkomstig die raamwerk gepubliseer ingevolge daardie Wet. 15
