Under section 3 of the Roads Ordinance, 1976 (Ordinance No 19 of 1976), I hereby declare that the existing public roads (Minor Roads 7661, 7662 and 7663), and portions of the existing public roads (Main Road 240 and Minor Roads 7647, 7659 and 7664), as described in the Schedule (paragraphs 1 to 7) to this notice and situated in the Saldanha Bay Local Municipality area, the locations and routes of which are indicated by means of an unbroken blue line marked A-B on plan RL.64/12 and unbroken blue and red lines marked A-B-C, C-D-E, B-F-G, D-F, C-I and B-H on plan RL.64/13 shall be closed (deproclaimed).
