SWELLENDAM MUNICIPALITY BY-LAW RELATING TO THE SUBMISSION OF BUILDING PLANS

To ensure uniformity with regard to the submission, consideration and approval of building plans in the jurisdictional area of the Municipality and to make additional provisions regarding the submission of building plans and the control of illegal construction work; and to provide for matters relating thereto.

PREAMBLE

WHEREAS section 156(2) and (5) of the Constitution provides that a Municipality may make and administer By-Laws for the effective administration of the matters which it has the right to administer, and to exercise any power concerning a matter reasonably necessary for, or incidental to, the effective performance of its functions;

AND WHEREAS Part B of Schedule 4 to the Constitution lists Building Regulations as a local government matter to the extent set out in sections 155(6) (a) and 155(7);

AND WHEREAS the Swellendam Municipality seeks to regulate building works and activities related thereto:

BE IT ENACTED by the Council of the Swellendam Municipality, as follows:—

1. Definitions

In this By-Law, the English text shall prevail in the event of an inconsistency between the different texts, and unless the context indicates otherwise:—

- **"Building Act"** means the National Building Regulations and Building Standards Act, 1977 (Act 103 of 1977) and includes the Building Regulations;
- **"Building Regulations"** means the National Building Regulations promulgated under GN R2378 of 12 October 1990;
- "Building contractor" means any person assigned the duties by the owner to commence with building works, and includes the owner;
- "Building works" means any building as described in the Building Act and includes minor building works, any renovations, alterations and other construction work related thereto;
- "Municipality" means the Swellendam Municipality and includes any political structure, political office bearer, duly authorised agent thereof, or a service provider fulfilling a responsibility under this By-Law assigned to it in terms of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) or any other law, as the case may be, or any employee

thereof acting in connection with this By-Law by virtue of a power vested in the Municipality and delegated, to such political structure, political office bearer, agent or employee;

"Organ of state" means an organ of state as defined in section 239 of the Constitution of the Republic of South Africa, 1996;

"owner" shall have the same meaning as described in the Building Act; and

"Person" means any natural person, juristic person, association or organ of state;

2. Application

Notwithstanding conflicting provisions in any other act, all persons, including organs of state, must submit building plans and specifications for consideration by the Municipality. An organ of state will only be exempt from complying with this By-Law if a certificate can be produced signed by the Minister of Justice or the Minister of State Security declaring that the submission of a building plan for a specific building may harm the security of the Republic of South Africa.

3. Interpretation

The Building Act will prevail to the extent that it is not in conflict with this By-Law. Words and phrases in this By-Law will have the same meaning as assigned to it in the Building Act, unless the context indicates otherwise.

4. Compliance and enforcement

- (1) No person shall without the prior approval in writing of the Municipality, erect any building or proceed with any building works in respect of which plans and specifications are to be drawn and submitted in terms of this By-Law or any other legislation or allow it to be erected.
- (2) A building contractor must, before commencing any building work, ensure that a building plan for the specific building works has been approved by the Municipality.
- (3) A building contractor must, at all times, keep a copy of the approved building plan at the building site where the building works are in progress and allow an authorised official of the Municipality to inspect the plan.
- (4) Where a person erects a building without a building plan approved by the Municipality or deviates from an approved building plan, the Municipality may instruct such person by notice to stop the erection of the building forthwith and/or to comply with the approved building plan.
- (5) Where the person served with a notice contemplated in subsection (4) fails to comply with such notice, the Municipality may approach a competent court for an order prohibiting any person from proceeding with the erection of such building or authorising the Municipality to demolish such building if the court is satisfied that such erection is contrary to or does not comply with the provisions of this By-Law or any approval or authorization granted thereunder.
- (6) A person who fails to comply with subsections (1) to (5) of this By-Law commits an offence.

5. Determination of tariffs

- (1) The Municipality may, in terms of its Tariff By-Law, determine tariffs and fees for any service rendered in terms of this By-Law which must be reviewed annually during the budget process.
- (2) Where a building was erected without a building plan, a tariff will be determined for the late application which will be payable over and above the ordinary tariff for consideration of such building plan.

6. Right of entry and inspection

- (1) Any duly authorised employee of the Municipality is authorised to inspect any premises within the municipal area in order to determine whether there is compliance with the provisions of this By-Law.
- (2) When entering premises in terms of subsection (1), such employee must on request by any person, identify him- or herself by producing written proof of authorisation.
- (3) The authorised employee may be accompanied by a person reasonably required to assist in conducting the inspection.
- (4) Any person who fails to give or refuses access to any authorised official, or obstructs or hinders him or her in the execution of his or her duties under this By-Law, or who fails or refuses to give information that he or she may lawfully be required to give to such official, or who gives false or misleading information knowing it to be false or misleading, commits an offence.

7. Offences and penalties

- (1) A person who commits an offence in terms of this By-Law shall upon conviction be liable to—
 - (a) a fine or imprisonment, or either such fine or imprisonment or to both such fine and such imprisonment and,
 - (b) in the case of a continuing offence, to an additional fine for each day on which such offence is continued.
- (2) Failure to comply with a notice, direction or instruction referred to in this By-Law constitutes a continuing offence.
- (3) In addition to any fines imposed in terms of sub paragraphs (a) and (b), a further amount equal to any costs or expenses found by the court to have been incurred by the Municipality as result of such contravention or failure, may be imposed by the court.

8. Short title and commencement

This By-Law shall be known as the Building Plans By-Law and shall come into operation on the date of promulgation thereof in the *Provincial Gazette*.
