I, Johannes Jurgens Brand, Western Cape Provincial Police Ombudsman, give notice in terms of section 17(3) of the Western Cape Community Safety Act, 2013 (Act 3 of 2013), of an investigation by the Office of the Western Cape Provincial Police Ombudsman concerning allegations that the South African Police Service in the Western Cape Province, contrary to their duties in terms of National Instruction 2/2012 – Version 02.00, entitled “Victim Empowerment”, issued in terms of section 25(1) of the South African Police Service Act, 1995 (Act 68 of 1995), is not providing the required level of services and support to protect and promote the rights of victims of crime in the Western Cape.
