IN TERMS OF THE PROVISIONS OF SECTIONS 58 AND 32 OF THE WESTERN CAPE GAMBLING AND RACING ACT, 1996 (ACT 4 OF 1996) ("ACT"), AS AMENDED, THE WESTERN CAPE GAMBLING AND RACING BOARD ("BOARD") HEREBY GIVES NOTICE THAT AN APPLICATION FOR THE PROCUREMENT OF A FINANCIAL INTEREST OF 5% OR MORE IN A HOLDER OF A ROUTE OPERATOR LICENCE IN THE WESTERN CAPE, HAS BEEN RECEIVED

Sun Slots (RF) (Pty) Ltd ("Sun Slots") entered into a share repurchase agreement with Grand Casino Investments (Pty) Ltd ("GCI"), a wholly-owned subsidiary of Grand Parade Investments Ltd ("GPI"), to repurchase the 30% financial interest held in Sun Slots by GCI. Sun International (South Africa) Limited, a wholly-owned subsidiary of Sun International Limited ("SIL") holds the remaining 70% financial interest in Sun Slots.

SIL subsequently entered into a subscription agreement with Sun Slots to procure a 30% financial interest in Sun Slots. Through this procurement, SIL will have a 100% indirect financial interest in Grand Gaming Western Cape (RF) (Pty) Ltd ("Grand Gaming"), a licensed Route Operator in the Western Cape.

SIL has applied to the Board for consent to procure a 5% or more financial interest in Grand Gaming as required in terms of Section 58 of the Act.

Section 33 of the Act requires the Board to ask the public to submit comments and/or objections to gambling licence applications that are filed with the Board. The conduct of gambling operations is regulated in terms of both the Act and the National Gambling Act, 2004. This notice serves to notify members of the public that they may lodge objections and/or comments to the above application on or before the closing date at the below-mentioned address and contacts. Since licensed gambling constitutes a legitimate business operation, moral objections for or against gambling will not be considered by the Board. An objection that merely states that one is opposed to gambling without much substantiation will not be viewed with much favour. You are hereby encouraged to read the Act and learn more about the Board's powers and the matters pursuant to which objections may be lodged. These are outlined in Sections 28, 30, 31 and 35 of the Act. Members of the public can obtain a copy of the objections guidelines, which is an explanatory guide through the legal framework governing the lodging of objections and the Board's adjudication procedures. The objections guidelines are accessible from the Board's website at www.wcgrb.co.za and copies can also be made available on request. The Board will consider all comments and objections lodged on or before the closing date during the adjudication of the application.

All comments and objections lodged must contain the name, address and contact number of the person objecting to the proposed application(s) or offering the comment and must state the grounds on which the objection and/or comment is based.

INGEVOLGE DIE BEPALINGS VAN ARTIKEL 58 EN 32 VAN DIE WES-KAAPSE WET OP DOBBELARY EN WEDRENNE, 1996 (WET 4 VAN 1996) ("WET"), SOOS GEWYSIG, GEE DIE WES-KAAPSE RAAD OP DOBBELARY EN WEDRENNE ("DIE RAAD") HIERMEE KENNIS DAT 'N AANSOEK VIR DIE VERKRYGING VAN 'N FINANSIËLE BELANG VAN VYF PERSENT OF MEER IN 'N ROETE-OPERATEURLISENSIEHOUDERS IN DIE WES-KAAP ONTVANG IS.

Sun Slots (RF) Edms Bpk ("Sun Slots") het 'n ooreenkoms met Grand Casino Investments Edms Bpk ("GCI"), 'n volfiliaal van Grand Parade Investments Bpk ("GPI"), aangegaan om die 30% finansiële belang wat GCI in Sun Slots besit, terug te koop. Sun International (South Africa) Bpk, 'n volfiliaal van Sun International Bpk ("SIL") besit die restant finansiële belang van 70% in Sun Slots.

SIL het daaropvolgend 'n subskripsie ooreenkoms met Sun Slots aangegaan om 'n 30% finansiële belang in Sun Slots te verkry. Deur hierdie verkryging sal SIL 'n indirekte finansiële belang van 100% in Grand Gaming Western Cape (RF) Edms Bpk ("Grand Gaming"), 'n gelisensieërde Roete Operateur in die Wes-Kaap, besit.

SIL het in terme van artikel 58 van die Wet aansoek by die Raad gedoen vir goedkeuring om 'n 5% of meer finansiële belang in Grand Gaming te verkry.

Artikel 33 van die Wet bepaal dat die Raad die publiek moet vra om kommentaar te lewer op en/of besware aan te teken teen dobbellisensie-aansoeke wat by die Raad ingedien word. Dobbelerksaamhede word kragtens die Wet sowel as die Nasionale Wet op Dobbelry, 2004 gereguleer. Hierdie kennisgewing dien om lede van die publiek in kennis te stel dat hulle voor die sluitingsdatum by ondergemelde adres en kontakte beswaar kan aanteken teen en/of kommentaar kan lewer op bogenoemde aansoeke. Aangesien gelisensieerde dobbelary 'n wettige besigheid is, word morele besware ten gunste van of teen dobbelary nie deur die Raad oorweeg nie. 'n Beswaar wat bloot meld dat iemand teen dobbelary gekant is sonder veel staving sal nie gunstig oorweeg word nie. U word hiermee aangemoedig om die Wet te lees en meer inligting te verkry oor die Raad se magte en die aangeleenthede op grond waarvan besware ingedien kan word. Dit word in artikels 28, 30, 31 en 35 van die Wet uiteengesit. Lede van die publiek kan 'n afskrif van die riglyne vir besware bekom, wat 'n gids is wat die werking verduidelik van die regsraamwerk wat die indiening van besware, publieke verhore en die Raad se beoordelingsprosedures reguleer. Die riglyne vir besware is verkrygbaar op die Raad se webwerf by www.wcgrb.co.za en afskrifte kan ook op versoek beskikbaar gestel word. Die Raad sal alle kommentaar en besware oorweeg wat op of voor die sluitingsdatum tydens die beoordeling van die aansoek ingedien word.

In die geval van skriftelike besware teen 'n aansoek moet die gronde waarop sodanige besware berus, verskaf word. Waar kommentaar ten opsigte van 'n aansoek gegee word, moet volle besonderhede en feite om sodanige kommentaar te staaf, verskaf word.
