**DEPARTMENT OF TRANSPORT AND PUBLIC WORKS: WESTERN CAPE  
NATIONAL LAND TRANSPORT ACT, 2009 (ACT 5 OF 2009)  
AMENDMENT OF NOTICE OF EXTRAORDINARY MEASURES IN DECLARED AREAS**

1. I, Daylin Mitchell, Provincial Minister of Transport and Public Works in the Western Cape, amend the Notice published under Provincial Notice 77/2021 in *Provincial Gazette* 8467 dated 23 July 2021 as follows:

(a) by the substitution for paragraph (a) of the following paragraph:

“(a) under section 91(2)(a) of the Act, the route and ranks, and a part of the Bellville Public Transport Interchange, set out in the Schedule, that are situated in the declared areas, are closed for the operation of any minibus taxi-type services for a period of two months (the closure period), commencing on 26 July 2021;”;

(b) by the substitution for paragraph (b) of the following paragraph:

“(b) under section 91(2)(b) of the Act, any operating licence or permit authorising any minibus taxi-type services on the closed route contemplated in paragraph (a) is suspended in respect of that route for the duration of the closure period;”;

(c) by the substitution for paragraph (c) of the following paragraph:

“(c) under section 91(2)(c) of the Act, and subject to paragraph (e), no person may, for the duration of the closure period, undertake any minibus taxi-type services on the closed route contemplated in paragraph (a), or in terms of an operating licence or permit suspended as contemplated in paragraph (b);”;

(d) by the substitution for the Schedule of the following Schedule:
