Now, therefore, under and by virtue of the powers vested in me as aforesaid, I do by this my Proclamation proclaim that in respect of the aforesaid municipalities, the year 1961, shall be the time required to be so specified.

## SCHEDULE.

The land shall upon incorporation be subject to the existing conditions and servitudes but excluding the following conditions which do not affect the land:—

- (a) Owners Reservation No. 14, dated 20th November, 1915, and Owners Reservation No. 15, dated 20th November, 1915;
- (b) Lease No. 31/50L whereby Elgin Fireclays, Limited, has the sole and exclusive right to work clay and fireclay as shown on Diagram S.G. No. A.4946/1949.

The land shall further be subject to the following conditions imposed by the Administrator:—

- (a) The owner shall not have the right to make or cause to be made upon the erf for any purpose whatsoever any bricks, tiles or earthenware pipes or other articles of such nature, nor shall he have the right (save and except to prepare the erf for building purposes) to dig or quarry any earth, gravel, lime or stone thereon.
- (b) No wood and iron buildings of any description shall be erected on the erf.
- (c) No slaughter poles, cattle kraals or cowsheds shall be erected, opened or carried on by any person whomsoever in the township.
- (d) No canteen, restaurant, shop, factory, industry, boarding-house, flat, nursing home or any place of business whatsoever shall be opened or conducted upon the erf.
- (e) Not more than one dwelling-house with the necessary outbuildings shall be erected on the erf except in special circumstances and then only with the consent in writing of the Administrator or body or person designated by him for the purpose.

The building and necessary outbuildings to be erected on the erf shall cost not less than R1,300. Outbuildings shall be built simultaneously with the dwelling-house, which shall be a complete house and not one partly built and intended for completion at a later date.

- (f) The erf shall be neatly fenced and the owner shall be obliged to use therefor hardwood, or iron palings or good wire fencing, or properly built stone, brick or cement walls. Moreover he shall not erect an unsightly fence, nor one of galvanized iron, canvas, or other fabric, or reeds, grass, softwood or other inflammable material. The fence shall be kept in proper repair by the owner.

## BYLAE.

Die grond is by inlywing onderworpe aan bestaande voorwaardes en serwitute maar sonder inbegrip van die volgende voorwaardes wat nie die grond raak nie:—

- (a) Eienaarsvoorbehoud No. 14 van 20 November 1915, en Eienaarsvoorbehoud No. 15 van 20 November 1915;

- (e) Nie meer as een woonhuis tesame met die nodige buitegeboue mag op die erf opgerig word nie behalwe onder spesiale omstandighede en dan slegs met die skriftelike toestemming van die Administrateur of liggaam of persoon vir dié doel deur hom aangewys.

Die gebou en nodige buitegeboue wat op die erf opgerig gaan word, moet minstens R1,300 kos. Buitegeboue moet gelyktydig met die woonhuis wat 'n voltooide huis moet wees en nie een wat gedeeltelik gebou en eers later voltooi gaan word nie, gebou word.

- (f) Die erf moet netjies omhein word en die eienaar is verplig om hardhout of ysterspitspale of goeie omheiningsdraad of behoorlik gemesselde klipsteen- of sementmure daarvoor te gebruik. 

**MACHADODORP MUNICIPALITY.—CAPITAL  
 DEVELOPMENT FUND BY-LAWS.**

The Administrator hereby, in terms of section *one hundred and one* of the Local Government Ordinance, 1939; publishes the following by-laws, which have been approved by him in terms of section *ninety-nine* of the said Ordinance:—

**MUNICIPALITY OF MACHADODORP.—CAPITAL  
 DEVELOPMENT FUND BY-LAWS.**

*Definitions.*

1. For the purpose of these by-laws, unless the context indicates otherwise—

- “advance” means any money lent or deemed to have been lent to a borrowing account;
- “borrowing account” means any account or fund of the Council to which money is lent or deemed to have been lent from the Fund;
- “Council” means the Village Council of Machadodorp;
- “Fund” means the Capital Development Fund, which is hereby instituted;
- “treasurer” means the Treasurer of the Council.

*Payments to the Fund.*

2. There shall be paid to the Fund—
- (a) subject to the provisions of any other law, such sums of money as the Council may, from time to time, decide to appropriate from accumulated revenue surpluses or from current revenues;
  - (b) The capital sum due by a borrowing account in accordance with the terms and conditions of repayment attaching to an advance; and
  - (c) interest payable on advances.

*Use of the Fund.*

3. The Council may make an advance to a borrowing account from the Fund to enable such borrowing account to finance capital expenditure for the creation of an asset or assets.

*Repayment of an Advance.*

4. Any advance shall be deemed to be due and owing to the Fund by the borrowing account to which it is made and shall be repaid to the Fund over a period not exceeding the estimated life of the assets to the creation of which it is applied, the said period and conditions of repayment to be such as the Council may determine.

*Interest on Advances.*

5. (1) When an advance is made the treasurer shall determine whether the asset or assets created therefrom is or are remunerative.
- (2) If the treasurer has, in terms of sub-section (1), determined that an asset is remunerative the borrowing account shall pay to the Fund interest on the advance made to it.
