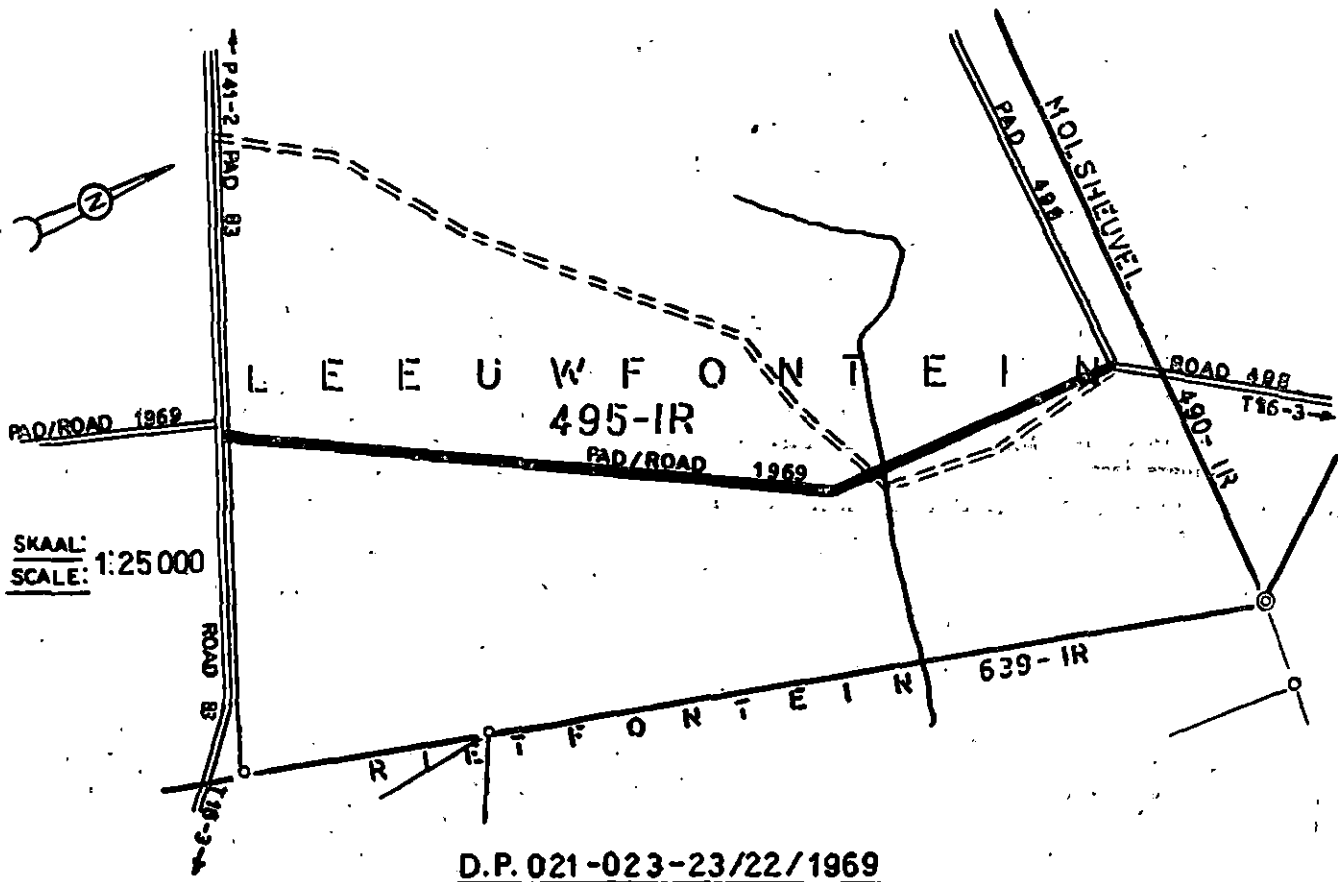

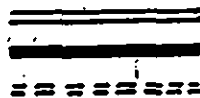

PERI-URBAN AREAS HEALTH BOARD.—AMENDMENT TO ELECTRICITY SUPPLY BY-LAWS.

The Administrator hereby, in terms of section one hundred and one of the Local Government Ordinance, 1939, publishes the following by-laws, which have been approved by him in terms of section ninety-nine of the said Ordinance:—

PERI-URBAN AREAS HEALTH BOARD.—AMENDMENT TO ELECTRICITY SUPPLY BY-LAWS.

Amend the Electricity Supply By-laws of the Peri-Urban Areas Health Board, published under Administrator's Notice No. 188, dated the 18th March, 1959, as amended, by the addition to Schedule 2 of the following:—

“ANNEXURE 3.

FEES PAYABLE FOR THE SUPPLY OF ELECTRICITY TO PREMISES SITUATED WITHIN THE AREA OF JURISDICTION OF THE KLIPRIVIERSOOG LOCAL AREA COMMITTEE.

Scale 1.—Domestic Scale.

This scale shall be applicable in respect of electricity supplied or made available to—

- (a) a dwelling;
- (b) a flat or a block of flats;
- (c) a home run by a charitable institution;
- (d) a nursing home and a hospital;
- (e) a licensed and a private hotel;
- (f) a boarding-house;
- (g) a residential club;

GESONDHEIDSRAAD VIR BUTE-STEDELIKE GEBIEDE.—WYSIGING VAN ELEKTRISITEITVOORSIENINGSVERORDENINGE.

Die Administrateur publiseer hierby ingevolge artikel honderd-en-een van die Ordonnansie op Plaaslike Bestuur, 1939, die volgende verordeninge wat deur hom ingevolge artikel nege-en-negentig van genoemde Ordonnansie goedgekeur is.

GESONDHEIDSRAAD VIR BUTE-STEDELIKE GEBIEDE.—WYSIGING VAN ELEKTRISITEITVOORSIENINGSVERORDENINGE.

Die Elektrisiteitvoorsiemingsverordeninge van die Gesondheidsraad vir Buite-Stedelike Gebiede, afgekondig by Administrateurskennisgewing No. 188 van 18 Maart 1959, soos gewysig, word hierby verder gewysig deur die volgende aan Bylae 2 toe te voeg:—

„AANHANGSEL 3.

GELDE BETAALBAAR VIR DIE VOORSIENING VAN ELEKTRISITEIT AAN PERSELE GELEÛ BINNE DIE REGSGEBIED VAN DIE KLIPRIVIEROOGSE PLAASLIKE GEBIEDSKOMITTEE.

Skaal 1.—Huishoudelike Skaal.

Hierdie skaal is van toepassing ten opsigte van elektrisiteit gelewer of beskikbaar gestel aan—

- (a) 'n woonhuis;
- (b) 'n woonstel of 'n woonstelgebou;
- (c) 'n tehuis van 'n liefdadigheidsinrigting;
- (d) 'n verpleeginrigting en 'n hospitaal;
- (e) 'n gelisensieerde en 'n privaathotel;
- (f) 'n losieshuis;
- (g) 'n woonklub;

- (h) a hostel;
- (i) a church or a church hall;
- (j) a club;
- (k) a public hall.

Tariff.

The tariff applicable to premises listed under Scale 1, shall be as follows:—

(i) *Area Charge.*—The area charge shall be payable whether electricity is consumed or not, and shall be as follows:—

- (a) 5c per month per 10 square feet in respect of the first 500 square feet floor area;
- (b) 2c per month per 10 square feet in respect of floor area additional to the first 500 square feet.

(ii) *Energy Charge.*—0.55c per unit per month for all units consumed.

'Floor area' for the purpose of this tariff, means the total area of the building, ascertained by internal measurement, of all rooms and passages but excluding any garage, stoep and open veranda.

Scale 2.—Business, Industrial and General Scale.

This scale shall be applicable in respect of electricity supplied or made available to—

- (a) a shop or commercial house;
- (b) an office building;
- (c) a café, tearoom or restaurant;
- (d) a combined shop and tearoom;
- (e) an industrial or factory undertaking;
- (f) a school or educational institution;
- (g) all other consumers not listed under Scale 1, 3 or 4.

Tariff.

The tariff applicable to premises listed under Scale 2, shall be as follows:—

- (i) A service charge per metering point of R2 per month whether electricity is consumed or not.
- (ii) An energy charge of 1.5c per unit for all units consumed.

Scale 3.—Demand Scale.

In case where the Board supplies electricity in bulk, the following tariff shall apply:—

- (i) A service charge per metering point of R2 per month whether electricity is consumed or not.
- (ii) A demand charge of R1.50 per kVA. of half-hourly maximum demand, subject to a monthly minimum charge of R10 whether electricity is consumed or not.
- (iii) An energy charge of 1c per unit for all units consumed.

Scale 4.—Temporary Supply.

A temporary supply for building purposes, fairs shall be provided for a period not exceeding five days. The charge for a temporary supply shall be as follows:—

- (i) A connection fee of R20 shall be payable.
- (ii) An energy charge of 2c per unit for all units consumed.

General.

1. *Connections.*—Only underground cable connections shall be made.

A charge of R60 shall be payable for each connection to the Board's supply mains.

2. *Reconnection Fees.*—(i) Where premises have been disconnected temporarily for non-payment of accounts or non-compliance with any of the Board's Electricity Supply By-laws or Regulations an amount of R2 shall be paid to the Board before reconnection of the premises shall be effected.

- (h) 'n koshuis;
- (i) 'n kerk of 'n kerksaal;
- (j) 'n klub;
- (k) 'n openbare saal.

Tarief.

Die tarief van toepassing op persele wat onder Skaal 1 ressorteer is as volg:—

(i) *Oppervlakteheffing.*—Die oppervlakteheffing is betaalbaar of elektrisiteit verbruik word of nie en is soos volg:—

- (a) Ten opsigte van die eerste 500 vierkante voet vloeroppervlakte: 5c per 10 vierkante voet per maand.
- (b) Ten opsigte van vloeroppervlakte bo die eerste 500 vierkante voet: 2c per 10 vierkante voet per maand.

(ii) *Elektrisiteitsheffing.*—0.55c per eenheid per maand vir alle eenhede wat verbruik word.

'Vloeroppervlakte' beteken vir die toepassing van hierdie skaal, die totale oppervlakte van die gebou soos dit deur binneafmeting van alle kamers en gange vasgestel is, uitsluitende motorhuis, stoep en oop veranda.

Skaal 2.—Handels-, nywerheid- en algemene skaal.

Hierdie skaal is van toepassing ten opsigte van elektrisiteit gelewer of beskikbaar gestel aan—

- (a) 'n winkel of handelshuis;
- (b) 'n kantoorgebou;
- (c) 'n kafee, teekamer of restaurant;
- (d) 'n gekombineerde winkel en teekamer;
- (e) 'n nywerheids- of fabrieksonderneming;
- (f) 'n skool of onderwysinrigting;
- (g) alle ander verbruikers wat nie onder Skaal 1 of 3 of 4 ressorteer nie.

Tarief.

Die tarief van toepassing op persele wat onder Skaal 2 ressorteer is as volg:—

- (i) 'n *Leweringsgeld* wat betaalbaar is of elektrisiteit verbruik word of nie van R2 per maand per meteraansluitpunt.
- (ii) 'n *Elektrisiteitsheffing* van 1.5c per eenheid vir alle eenhede wat verbruik word.

Skaal 3.—Aanvraag skaal.

In gevalle waar die Raad elektrisiteit by die groot maat lewer word die volgende tarief toegepas:—

- (i) 'n *Leweringsgeld* van R2 per meteraansluitpunt per maand of elektrisiteit verbruik word of nie.
- (ii) 'n *Verbruiksheffing* van R1.50 per kVA. van half-uurlikse maksimum aanvraag, onderworpe aan 'n minimum heffing van R10 per maand of elektrisiteit verbruik word of nie.
- (iii) 'n *Elektrisiteitsheffing* van 1c per eenheid vir alle eenhede wat verbruik word.

Skaal 4.—Tydelike toevoer.

Tydelike toevoer vir boudoeleindes, kermisse, word vir 'n tydperk van hoogstens vyf dae verskaf.

Die tarief vir tydelike toevoer is as volg:—

- (i) 'n *Aansluitingsgeld* van R20 is betaalbaar.
- (ii) 'n *Elektrisiteitsheffing* van 2c per eenheid vir alle eenhede wat verbruik word.

Algemeen.

1. *Aansluitings.*—Slegs ondergrondse kabel-aansluitings word gemaak.

Vir elke aansluiting aan die Raad se hooftoevoerleiding is 'n heffing van R60 betaalbaar.

2. *Heraansluitingsgelde.*—(i) Wanneer 'n perseel weens die nie-betaling van rekenings of die nie-nakoming van enige van die Raad se Elektrisiteitsverordeninge of -regulasies tydelik afgesluit is, moet 'n bedrag van R2 aan die Raad betaal word voordat heraanluiting van die perseel geskied.

(ii) Where premises have been disconnected temporarily for a period of less than 14 days at the request of the consumer, an amount of R2 shall be paid to the Board before reconnection of the premises shall be effected.

3. *Fees for Attendance to Consumers' Faults.*—When the Electricity Department is called upon to attend to a failure of supply and where such failure of supply is found to be due to a fault in the installation or due to faulty operation of apparatus used in connection therewith, an amount of R2 shall be paid by the consumer for each such attendance.

4. *Fees for Special Reading of Meters.*

Consumers' meters will be read, as near as is reasonably possible, at intervals of one month. Where the consumer requires his meter to be read at any time other than the appointed date, a fee of R1 shall be payable for such reading.

5. *Fees for Testing of Electricity Meters.*—If a consumer has reason to suppose that an electricity meter is out of order or is registering incorrectly, the meter shall be tested by the Board on payment by the consumer of an amount of R7. This amount shall be refunded if the meter is found to register more than 5 per cent fast or slow and an allowance or addition calculated in terms of the Electricity By-laws, shall be made to the consumer's account from the last reading in the month during which the accuracy of the meter was first disputed in writing by the consumer.

6. *Fees for Inspection and Testing of Installations.*—Upon receipt of notification, in terms of the Board's Electricity Supply By-laws that an installation or an addition to an installation has been completed and is ready for testing and inspection, such test and inspection shall be carried out free of charge.

If the installation is found to be incomplete or defective or fails in any way to comply with the Board's Electricity Supply By-laws and Wiring Regulations, the Board shall not connect the installation until such defect or failure shall have been remedied by the contractor and a further test and inspection carried out. The fee chargeable for each such additional test and inspection shall be R5, payable in advance.

7. *Meter Rentals.*—No rental shall be charged in respect of meters required to measure the consumption of electricity under the various scales of the tariff.

Where additional meters are required by the consumer for his own convenience and such meters are provided by the Board, a rental of R0.25 per meter per month shall be payable.

8. *Deposits.*—Except in the case of the State, the Provincial Administration or the South African Railways, every applicant for a supply of electricity shall upon signing the undertaking referred to in section 13 of the by-laws deposit with the Board an amount determined by the Secretary/Treasurer from time to time: Provided that such deposit shall not be less than R5."

BRONKHORSTSPRUIT MUNICIPALITY.—PROPOSED ALTERATION OF BOUNDARIES.

It is hereby notified in terms of section ten of the Local Government Ordinance, 1939, that a petition has been presented to the Administrator by the Village Council of Bronkhorstspuit praying that he will, in the exercise of the powers conferred upon him by sub-section (7) of section nine of the said Ordinance, alter the boundaries of the Municipality of Bronkhorstspuit by the inclusion of the area described in the Schedule hereto.

It is competent for any person interested within 30 days of the first publication hereof in the *Provincial Gazette* to present to the Administrator a counter petition setting forth the ground of objection to the said proposal.

(ii) Wanneer 'n perseel op versoek van die verbruiker vir 'n tydperk van minder as 14 dae afgesluit word, moet 'n bedrag van R2 aan die Raad betaal word voordat heraansluiting van die perseel geskied.

3. *Gelde vir die herstel van defekte waarvoor die verbruiker verantwoordelik is.*—Wanneer die Elektrisiteitsafdeling aangese word om 'n onderbreking van toevoer te herstel en wanneer bevind word dat sodanige onderbreking te wyte is aan 'n fout in die installasie of aan foutiewe hantering van die apparaat wat in verband daarmee gebruik word, moet die verbruiker 'n bedrag van R2 vir elke sodanige herstelling van toevoer betaal.

4. *Gelde vir spesiale meteraflesing.*—Sover dit redelik moontlik is, word verbruikers se meters met tussenpose van een maand afgelees. Wanneer die verbruiker verlang dat sy meter op enige ander tyd as die vasgestelde datum afgelees word, is 'n bedrag van R1 ten opsigte van sodanige aflesing betaalbaar.

5. *Gelde vir toets van elektrisiteitsmeters.*—As 'n verbruiker rede het om te vermoed dat 'n elektrisiteitsmeter nie in orde is nie of verkeerd registreer, moet die meter deur die Raad getoets word, mits die verbruiker 'n bedrag van R7 stort. Die bedrag moet terugbetaal word indien bevind word dat die meter meer as 5 persent te vinnig of te stadig registreer, en 'n bedrag wat ingevolge die Elektrisiteitsverordeninge bereken word, moet van die laaste meteraflesing gedurende die maand waarin die verbruiker vir die eerste keer die noukeurigheid van die meter skriftelik in twyfel getrek het, van die verbruiker se rekening afgetrek of daaraan toegevoeg word.

6. *Gelde vir inspeksie en toets van installasies.*—By ontvangs van kennisgewing, ingevolge die Raad se Elektrisiteitsverordeninge, dat 'n installasie of 'n uitbreiding van 'n installasie voltooi is en gereed is om geïnspekteer en getoets te word, word so 'n toets en inspeksie kosteloos uitgevoer.

Indien bevind word dat die installasie onvolledig of gebrekkig is, of in enige opsig nie aan die Raad se Elektrisiteitsverordeninge en Bedradingsregulasies voldoen nie, mag die Raad die installasie nie aansluit voordat so 'n gebrek of tekortkoming deur die aannemer reggemaak en 'n verdere toets en inspeksie uitgevoer is nie. 'n Bedrag van R5 word vir elke sodanige addisionele toets en inspeksie gevra en is vooruitbetaalbaar.

7. *Huur van meters.*—Geen huurgeld is betaalbaar ten opsigte van meters wat vereis word om die elektrisiteitsverbruik volgens die verskillende skale van die tarief te meet nie.

Waar addisionele meters deur die verbruiker vir sy eie gerief verlang en deur die Raad verskaf word, is 'n huurgeld van R0.25 per maand per meter betaalbaar.

8. *Deposito's.*—Behalwe in die geval van die Staat, die Provinsiale Administrasie of die Suid-Afrikaanse Spoorweë, moet elke applikant wat aansoek doen om die verskaffing van elektrisiteit, by ondertekening van die onderneming waarna in artikel 13 van die verordeninge verwys word, by die Raad 'n bedrag deponeer wat van tyd tot tyd deur die Sekretaris/Tesourier bepaal word: Met dien verstande dat sodanige deposito nie minder is as R5 nie."

DRAFT ORDINANCE

To amend the Mineral Baths (Control and Management) Ordinance, 1933.

BE IT ENACTED by the Provincial Council of Transvaal as follows:—

Amendment of section 4 of Ordinance 10 of 1933 as amended by section 2 of Ordinance 16 of 1960.

1. (1) Section *four* of the Mineral Baths (Control and Management) Ordinance, 1933, is hereby amended by—

- (a) the substitution in sub-section (1) for the words "once in every three months" of the words "four times per year calculated from the first day of January"; and
- (b) the deletion in paragraph (b) of sub-section (7) of the expression "who shall submit at each ordinary meeting of the board for information a schedule of all payments made since the last meeting"

(2) Paragraph (a) of sub-section (1) shall be deemed to have come into operation on the first day of January, 1962, and paragraph (b) of that sub-section shall be deemed to have come into operation on the first day of November 1953.

Short title.

2. This Ordinance shall be called the Mineral Baths (Control and Management) Amendment Ordinance, 1962. T.A.A. 3/1/52/10.

To amend the Wheel Tax Ordinance, 1940.

Amendment of section 4 of Ordinance 1 of 1941, as amended by section 2 of Ordinance 3 of 1942, as substituted by section 3 of Ordinance 30 of 1958 and as amended by section 1 of Ordinance 12 of 1959.

1. Section *four* of the Wheel Tax Ordinance, 1940, is hereby amended by the substitution for sub-paragraph (ii) of paragraph (a) of the following sub-paragraph:—

- "(ii) a state in respect of which the Secretary for Defence certifies that it is a friendly state and that the vehicle is intended to be used exclusively for military purposes in the Republic;"
