PROKLAMASIE

Nademaal ek daarvan in kennis gestel is dat vakatures ontstaan het in die verteenwoordiging van die kiesafdelings Noordrand, Potgietersrus en Witbank, in die Provinsiale Raad van Transvaal, weens die verkiesing van onderskeidelik Gert Thomas du Preez, Johannes Christoffel van Rooyen en Izak Zirk Lombard op 16 November 1970 tot die Senaat van die Republiek van Suid-Afrika; en

Nademaal dit wenslik geag word dat die vakatures in die verteenwoordiging in die Provinsiale Raad ten opsigte van vermelde kiesafdelings aangevul word;

So is dit dat ek, kragtens en ingevolge die bevoegdheid aan my verleë by artikel 88, gelees met artikels 34 en 35 van die Wet tot Konsolidasie van die Kieswette, 1946 (Wet No. 46 van 1946), soos gewysig, hierby verklaar dat vakatures bestaan in die verteenwoordiging van die kiesafdelings hierbo genoem in die Provinsiale Raad van Transvaal en hierby verklaar —

- (1) dat Woensdag, die tiende dag van Maart 1971, vasgestel is as die dag waarop die nominasiehowe sitting sal hou om nominasies te ontvang van kandidate vir verkiesing as Provinsiale Raadslede vir die kiesafdelings hierbo vermeld;
- (2) dat die plekke beskryf in die tweede kolom van die Bylae hiervan die plekke is waar voormelde nominasiehowe sitting moet hou vir sodanige afdelings;
- (3) dat genoemde nominasiehowe sitting moet hou om tienuur in die voormiddag van voormelde dag;
- (4) dat, ingeval 'n stemming nodig word in voormelde kiesafdelings deurdat meer as een persoon wettig genomineer is by die sluiting van die sitting van elk van voormelde nominasiehowe vir sodanige afdelings, die stemming op Woensdag, die een-en-twintigste dag van April 1971, moet plaasvind, om sewe-uur in die voormiddag moet begin en om nege-uur in die aand van genoemde dag moet sluit; en
- (5) dat die persone genoem in die derde kolom van die Bylae hiervan, die kiesbeamptes is en hierby as sodanig benoem word, by die verkiesing in die kiesafdelings waarvan die name in die eerste kolom van gemelde Bylae teenoor die beskrywings of name van sodanige persone voorkom.

PROVINCIAL COUNCIL OF TRANSVAAL:  
BY-ELECTIONS.

PROCLAMATION

by the Honourable the Administrator of the  
Province Transvaal.

Whereas I have been notified that vacancies have occurred in the representation of the Electoral Divisions of North Rand, Potgietersrus and Witbank, in the Provincial Council of Transvaal, on account of the election of respectively Gert Thomas du Preez, Johannes Christoffel van Rooyen and Izak Zirk Lombard on the 16th November, 1970, to the Senate of the Republic of South Africa; and

Whereas it is deemed desirable that the vacancies in the representation in the Provincial Council of the said electoral divisions be filled;

Now, therefore, under and by virtue of the powers and authority vested in me by section 88, read with sections 34 and 35 of the Electoral Consolidation Act, 1946 (Act No. 46 of 1946), as amended, I hereby declare that vacancies exist in the representation of the above-mentioned electoral divisions in the Provincial Council of Transvaal and I hereby declare —

- (1) that Wednesday, the tenth day of March 1971, shall be the day on which the nomination courts shall sit to receive nominations of candidates for election as members of the Provincial Council for the electoral divisions mentioned above;
- (2) that the places described in the second column of the Schedule hereto shall be the places at which the nomination courts shall sit as aforesaid for such divisions;
- (3) that the said nomination courts shall sit at ten o'clock in the forenoon of the aforesaid day;
- (4) that if a poll becomes necessary in the electoral divisions aforesaid for the reason that more than one person shall have been duly nominated at the close of the sitting of each of the said nomination courts for such divisions, the poll shall be taken on Wednesday, the twenty-first day of April 1971, and shall commence at seven o'clock in the forenoon and close at nine o'clock in the evening of the said day; and
- (5) that the persons mentioned in the third column of the Schedule hereto shall be and is hereby appointed to be the returning officers at the election in the electoral divisions, the names of which appear in the first column of the said Schedule opposite the descriptions or names of such persons.
