SPRINGS AMENDMENT SCHEME 1/81.

Springs Town-planning Scheme 1, 1948, approved by virtue of Administrator's Proclamation 13 dated 28 January, 1948, is hereby further amended and altered in the following manner:—

(1) The map as shown on Map 3, Amendment Scheme 1/81.

(2) Clause 15(a), Table "C", by the addition of the following proviso:—

(45) The following conditions shall apply to Erven 32 up to and including 35 and Erven 110 and 111, New Era Township:—

- (a) The elevational treatment of all buildings shall conform to good architecture so as not to interfere with the amenities of the neighbourhood.
- (b) Neither the owner nor any other person have the right save and except to prepare the erf for building purposes, to excavate therefrom any material without the written consent of the Council.
- (c) No animal as defined in the Local Authorities Pounds Regulations framed under the Local Government Ordinance, 17 of 1939, shall be kept on the erf.
- (d) Where, in the opinion of the Council, it is impracticable for stormwater to be drained from higher-lying erven direct to a public street the owner of the erf shall be obliged to accept and/or permit the passage over the erf of such stormwater: Provided that the owners of any higher-lying erven, the stormwater from which is discharged over any lower-lying erf, shall be liable to pay a proportionate share of the cost of any pipeline or drain which the owner of such lower-lying erf may find necessary to lay or construct for the purposes of conducting the water so discharged over the erf, and provided further that, in the event of a dispute between the parties as to the nature or the position of the pipeline or drain, or the allocation of the cost thereof, the matter shall be referred to the Administrator, or his nominee, whose decision shall be final.






EDENVALE MUNICIPALITY: AMENDMENT TO BY-LAWS FOR FIXING FEES FOR THE ISSUING OF CERTIFICATES AND FURNISHING OF INFORMATION.

The Administrator hereby, in terms of section 101 of the Local Government Ordinance, 1939, publishes the by-laws set forth hereinafter, which have been approved by him in terms of section 99 of the said Ordinance.

The By-laws for Fixing Fees for the Issuing of Certificates and Furnishing of Information of the Edenvale Municipality, published under Administrator's Notice 1467, dated 24 December, 1969, as amended, are hereby further amended by the addition after item 14 under the Schedule of the following:

"15(1). For copies of the scheme clauses of the Edenvale Town-planning Scheme, 1954, each: R10.


