- (a) 'n Kommissie kragtens artikel 2(1) van die Ordonnansie benoem het om ondersoek in te stel na die regsgeldigheid en regverdiging van die beweerde onreëlmathede in verband met sekere sekuriteitsaangeleenthede in die Sekuriteitsdepartement van die Stadsraad van Johannesburg, soos uiteengesit in onlangse koerantverslae, en om verder ondersoek in te stel na die kwessie of daar enige skending van enige ordonnansie, regulasie of ander wet in verband met die beveiliging van die Raad se inligting in verband met sekuriteitsaangeleenthede voorgekom het;
- (b) sy Edele Regter V.G. Hiemstra en mnr. W.J. van den Berg kragtens artikel 3(1) van die Ordonnansie as lede van die Kommissie benoem het;
- (c) sy Edele Regter V.G. Hiemstra kragtens artikel 3(2) van die Ordonnansie as Voorsitter van die Kommissie aangewys het;
- (d) advokaat D.M. Fine, SA en advokaat W.L. Wapener kragtens artikel 3(4) van die Ordonnansie aangestel het om getuies te lei en getuienis aan die kommissie te bied; en
- (e) mnr. F. Malherbe, assistent-stadsekretaris van die Stadsraad van Roodepoort kragtens artikel 3(4) van die Ordonnansie as Sekretaris vir die Kommissie aangestel het.

**CITY COUNCIL OF JOHANNESBURG: APPOINTMENT OF COMMISSION OF INQUIRY INTO ALLEDGED ILLEGAL OR IRREGULAR CONDUCT IN REGARD TO CERTAIN SECURITY MATTERS**

The Administrator hereby in terms of section 2(1) of the Commissions of Inquiry Ordinance, 1960 (Ordinance 9 of 1960), hereafter referred to as the Ordinance, makes known that he —

- (a) has in terms of section 2(1) of the Ordinance, appointed a commission to inquire into the validity and justification of alledged irregularities in connection with certain security matters in the Security Department of the City Council of Johannesburg, as exposed in recent press reports, and to further investigate the question whether any violation of any ordinance, regulation or other act in regard to the safeguarding of the Council's information in connection with security matters have occurred;
- (b) has in terms of section 3(1) of the Ordinance appointed the Honourable Judge V.G. Hiemstra and Mr W.J. van den Berg as members of the Commission.
- (c) has in terms of section 3(2) of the Ordinance designated the Honourable Judge V.G. Hiemstra as Chairman of the Commission.
- (d) has in terms of section 3(4) of the Ordinance appointed advocate D.M. Fine, SC and advocate W.L. Wapener to lead witnesses and submit evidence to the Commission; and
- (e) has in terms of section 3(4) of the Ordinance appointed Mr F. Malherbe, assistant city secretary of the City Council of Roodepoort as Secretary of the Commission.
