And whereas I am empowered by section 17 of the  
Local Government Affairs Council Act (House of  
Assembly), 1989 (Act No. 84 of 1989), as amended by  
State President's Proclamation No. R. 20, 1993, dated  
26 March 1993, to assign the administration of a law  
relating to local government, which I administer, to the  
Local Government Affairs Council;

Now, therefore, I Daniël Jacobus Hough, Administra-  
tor of the Province of the Transvaal, hereby under sec-  
tion 17 of the Local Government Affairs Council Act  
(House of Assembly), 1989 (Act No. 84 of 1989), and  
with effect from 1 April 1993, assign the administration  
of the provisions of a law mentioned in the Schedule as  
are more fully indicated in relation to that law in the said  
Schedule to the Local Government Affairs Council.
