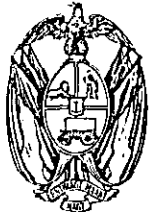

OORGANGSWET OP PLAASLIKE REGERING, 1993  
(WET No. 209 VAN 1993)

OPSKORTING VAN FUNKSIES VAN AFBAKENINGSRAAD VIR PLAASLIKE OWERHEIDSGEBIEDE INGESTEL KRAGTENS ARTIKEL 7A VAN DIE WET OP DIE BEVORDERING VAN PLAASLIKE OWERHEIDSAANGELEENTHEDE, 1993 (WET No. 91 VAN 1983)

Ek, Daniël Jacobus Hough, Administrateur van Transvaal, kragtens artikel 10 (1) (a) en (b) van die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993), en met die instemming van die Provinsiale Komitees vir Plaaslike Regering, vaardig ek hierby die volgende maatreël uit:

### PROCLAMATION

No. 53 (Administrator's), 1994

LOCAL GOVERNMENT TRANSITION ACT, 1993  
(ACT No. 209 OF 1993)

SUSPENSION OF FUNCTIONS OF DEMARCATION BOARD FOR LOCAL GOVERNMENT AREAS ESTABLISHED UNDER SECTION 7A OF THE PROMOTION OF LOCAL GOVERNMENT AFFAIRS ACT, 1983 (ACT No. 91 OF 1983)

I, Daniël Jacobus Hough, Administrator of the Transvaal, under section 10 (1) (a) and (b) of the Local Government Transition Act, 1993 (Act No. 209 of 1993), and with the concurrence of the Provincial Committee's for Local Government, hereby make the following enactment:

- (a) The functions of the Demarcation Board for Local Government Areas, established under section 7A of the Promotion of Local Government Affairs Act, 1983 (Act No. 91 of 1983), are suspended; and
- (b) the Promotion of Local Government Affairs Act, 1983, is amended by the repeal of sections 7A to 7H and 17A.
