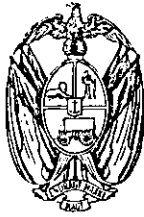

### KOMMISSIE VAN ONDERSOEK: ENNERDALE BESTUURSKOMITEE

Ingevolge artikel 2, saamgelees met artikel 4, van die Ordonnansie op Kommissies van Onderzoek, 1960 (Ordonnansie No. 9 van 1960), word hiermee bekendgemaak dat die Premier van die Pretoria-Witwatersrand-Vereeniging-provinsie ingevolge artikel 170ter (1) (a) van die Ordonnansie op Plaaslike Bestuur, 1939 (Ordonnansie No. 17 van 1939), **mnr. W. Krugel**, Identiteitsnommer 3007015023007, as 'n Kommissie van Onderzoek aangestel het om die volgende beweerde onreëlmatighede by die Ennerdale Bestuurskomitee te ondersoek en daarvoor aan hom verslag te doen:

- (a) Aanstelling van raadgewende ingenieurs;
- (b) toekenning van huise aan familieledede;
- (c) eise vir vervoertoelae;
- (d) toe-eiening van munisipale eiendom deur komiteede;
- (e) toekenning van behuisingskontrakte;
- (f) watertoevoer na eiendom van 'n lid van die bestuurskomitee;
- (g) misbruik van riooldienste deur 'n lid van die bestuurskomitee;
- (h) verkoop van Erf 334, Lawley;
- (i) toekenning van nywerheidsgrond aan Jaylala Enterprises BK;
- (j) betrokkenheid van 'n lid van die bestuurskomitee by die kontrak vir die bou van 'n swembad;

### COMMISSION OF INQUIRY: MANAGEMENT COMMITTEE OF ENNERDALE

In terms of section 2, read with section 4, of the Commissions of Inquiry Ordinance, 1960 (Ordinance No. 9 of 1960), it is hereby made known that the Premier of the Pretoria-Witwatersrand-Vereeniging Province has in terms of section 170ter (1) (a) of the Local Government Ordinance, 1939 (Ordinance No. 17 of 1939), appointed Mr W. Krugel, Identity Number 3007015023007, as a Commission of Inquiry to conduct an investigation into and to report to him on the following alleged irregularities committed at the Management Committee of Ennerdale:

- (a) Appointment of consulting engineers;
- (b) allocation of houses to family members;
- (c) claims for transport allowances;
- (d) appropriation of municipal property by committee members;
- (e) allocation of housing contracts;
- (f) water connections to property of a committee member;
- (g) misuse of sewage services by a committee member;
- (h) sale of Stand 334, Lawley;
- (i) allocation of industrial property to Jaylala Enterprises CC;
- (j) involvement of a committee member in the contract for the building of a swimming-pool;

- (k) misbruik van munisipale voertuie;  
 (l) privatisering van munisipale dienste aan maatskappye waarin bestuurskomitee lede 'n belang het;  
 (m) betrokkenheid van 'n lid van die bestuurskomitee by die kontrak vir die bou van toilette by die Elandsfontein Plesieroord;  
 (n) toekenning van kontrakte aan familie lede van 'n lid van die bestuurskomitee;  
 (o) gebruik van munisipale sale deur 'n lid van die bestuurskomitee;  
 (p) betrokkenheid van 'n lid van die bestuurskomitee by A & F Garage Equipment;  
 (q) toekenning van Stocks en Stocks huise;  
 (r) toekenning van huise in Ennerdale-uitbreiding 8;  
 (s) toelaes betaal aan lede van die bestuurskomitee;  
 (t) die aanstelling van 'n bou-opsigter; en  
 (u) viktimisasie aan sekere beamptes deur lede van die bestuurskomitee.

- (k) misuse of municipal vehicles;  
 (l) privatisation of municipal services to companies in which committee members are involved;  
 (m) involvement of a committee member in the contract for the building of toilets at the Elandsfontein pleasure resort;  
 (n) awarding of contracts to family members of a committee member;  
 (o) use of municipal halls by a committee member;  
 (p) involvement of a committee member in A & F Garage Equipment;  
 (q) allocation of Stocks and Stocks houses;  
 (r) allocation of houses in Ennerdale Extension 8;  
 (s) allowances paid to committee members;  
 (t) appointment of a clerk of works; and  
 (u) victimisation of certain officials by committee members.
