The Honel GAM 80 – 480 Series Bridge Deck Expansion Joints are multi-element gland-and-claw bridge-deck joints, which may be installed in new concrete bridge structures, as well as on rehabilitation projects. The joints have two to six glands to accommodate joint movements up to 480 mm.

The joints consist of edge beams and one or more intermediate beams. The intermediate beams are supported on and rigidly attached to joist beams which are supported on bearings in support boxes on each side of the joint. Above each joist beam are precompressed elastomeric sliding pads at bearing positions to prevent the joist beams from lifting off the bearings under traffic conditions. Elastomeric control springs are fitted between the beams to ensure an equal spacing between them and to prevent tilting of the beams. The edge beams and support boxes are rigidly anchored to the reinforced concrete by means of fish-plate or shear-connector anchors.
