The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of section 52(2) (a) of the Independent Broadcasting Authority Act, Act No 153 of 1993 ("the IBA Act") as amended, that it has received an application from Vaal University of Technology FM ("VUT FM") for the amendment of Vaal Triangle Technikon's broadcasting licence in terms of section 52(1) (c) of the Act, as per the schedule below.

Vaal University of Technology FM must, at the time of submitting its written response, furnish proof to the Authority's satisfaction that it has delivered a copy of the response by hand, or has sent a copy of the response by registered mail or by facsimile, to the relevant persons having made written representations.
