



## 1. GENERAL INFORMATION

- 1.1 Applications for permits must be addressed to the International Trade Administration Commission, Private Bag X 753, Pretoria or delivered by hand to the DTI Campus, (Block E) 77 Meintjies Street, Sunnyside, Pretoria, 0002.
- 1.2 Applications for permits must be submitted according to the requirements of the attached application form (**See Annexure A**). If the space provided in the application form is insufficient, please use the format of the application form to submit the requested information.
- 1.3 If all the information requested in the application form is not submitted, the application will not be considered, and the applicant will be notified of the deficiencies in the application.
- 1.4 Used overcoats are subject to Import Control Regulations and Import Control permits will be issued in cases where rebate permits are issued.
- 1.5 Each rebate permit issued defines the period during which the goods concerned can be cleared with rebate using the permit, and the period shall be for a calendar year, starting from the date on which the permit was issued, or as decided upon by the International Trade Administration Commission (ITAC).

2.1.8 Containers may only be opened if an inspector from Import and Export Control Section of ITAC is present.

2.1.9 Records, as required by SARS, must be kept in respect of used coats cleared with rebate of the duty.

2.1.10 Records of any used coats obtained from SACU should be kept and must be made available during inspection or when requested by ITAC. These records will be invoices, which will clearly show:

- The date of the purchase.
- The mass (kg) and sales value (R) of the used overcoats.

2.1.11 Bill of entry for import, commercial invoice, and bill of lading must be kept. These records must provide a clear documentation trail from the point of order to the actual receiving of the goods.

2.1.13 All records stated above must be kept for at least five years and be made available for inspection and investigation purposes.

"Category B", in respect of a private consulting practice in natural sciences, shall mean a partner, a sole proprietor, a director, or a member who, jointly or severally with his other partners, co-directors or co-members, bears the risk of the business, takes full responsibility for the liabilities of such practice, performs work of a conceptual nature in natural sciences and development, provides strategy guidance in planning and executing a project and/or carries responsibility for quality management pertaining to a project;

"Category C", in respect of a private practice in natural sciences, shall mean all salaried professional and technical staff performing work of a natural scientific nature and who carry the direct technical responsibility for one or more specific activities related to a project. A person referred to in Category B may also fall in this category if such person performs work of a natural scientific nature at this level;

"Category D", in respect of a private consulting practice in natural sciences, shall mean all other salaried technical staff with adequate expertise and relevant experience performing work of a natural scientific nature with direction and control provided by any person contemplated in Categories A or B or C.
