

SECTIONS 7 AND 8 AS NATIONAL ROAD N7 SECTIONS 6 AND 7 – DISTRICT OF
NAMAQUALAND (FROM NORTHERN CAPE/WESTERN CAPE PROVINCIAL BORDER TO
GARIES)**

By virtue of section 40(1)(a) of the South African National Road Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), I hereby declare Provincial Road Trunk Road 11 Sections 7 and 8, also known as Route N7, as declared by Administrator Notice no. 267 of 1971 and all other Notices which might be relevant to this section of road, commencing from its intersection with the Northern Cape/Western Cape Provincial Border, also the common boundary between the farms Brintjes Hoogte 40 and Meul, from where it proceeds in a general northerly direction along the existing Provincial Road Trunk Road 11 Sections 7 and 8 up to a point where it joins the existing National Road N7 Section 7 as declared by Declaration no. 2693 of 1990 on the common boundary between Remainder Erf 166 of Garies and Portion 2 of the farm Skuins Kraal 427, to be a National Road.



By virtue of section 40(1)(a) of the South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare Provincial Road Trunk Road 67 Sections 1 to 4, also known as the N8 (R64), all as declared by Administrator Notices no's. 139 of 1966, 420 of 1971, 173 of 1958, 128 of 1952 and 162 of 1957 and all other Notices which might be relevant to this section of road commencing from a point on Route N10, also known as road Trunk Road 17 on the farm Boegoeberg 48, from where it proceeds in a general easterly direction along the existing Provincial Road Trunk Road 67 Sections 1 to 4 through the township of Griekwastad, including only the roadway and shoulders (surfaced or gravel) but excluding kerbs, channels, sidewalks and parking areas through the township of Griekwastad, bypassing the township of Campbell up to its junction with Provincial Road Trunk Road 5, also known as Route R31 on the farm Bullfontein 82, west of the township of Kimberley, to be a National Road.

(FROM NORTHERN CAPE/NORTH WEST PROVINCIAL BORDER TO KEIMOOES]**

By virtue of section 40(1)(a) of the South African National Roads Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare (I) Provincial Road Trunk Road 16 Sections 2 to 4, also known as road R27, commencing from its intersection with the Northern Cape/Western Cape Provincial Border, also the common boundary between farms Meulsteen Vley Extension 646 and Vierfontein 240, from where it proceeds in a general north-easterly direction along the existing Provincial Road Trunk Road 16 Sections 2 to 4, bypassing the townships of Niewoudtville, and Soetwater, through the township of Calvinia, bypassing the township of Downes up to its junction with Provincial Road Trunk Road 12 Section 1 on the farm Farm 742, ± 5km east of Downes, and (II) Provincial Road Trunk Road 12 Sections 1 to 3, also known as Route R27, continuing from the junction with Provincial Road Trunk Road 16 Section 4 on the farm Farm 742 proceeding in a general northerly direction along existing Provincial Road Trunk Road 12 Sections 1 to 3, bypassing the township of Brandvlei, through the township of Kenhardt up to its junction with Provincial Road Trunk Road 71 Section 2, also known as Route N14 in Keimoes, including only the roadway and shoulders (surfaced or gravel) but excluding kerbs, channels, sidewalks and parking areas through the townships of Calvinia, Kenhardt and Keimoes all as declared by Administrator Notices no 157 of 1951, 133 of 1958, 171 of 1964, 9 of 1959, 20 of 1956 and 235 of 1962 and all other Notices which might be relevant to this section of road, to be a National Road.
