**Adjusted allocations in terms of the 2005 Division of Revenue Act (Act No. 1 of 2005)**

## **Explanatory Memorandum to the allocations set out in Schedule 3 of Annexure A**

This gazette is published in terms of Section 11 of the 2005 Division of Revenue Act (Act No.1 of 2005) and provides information on adjustments to existing allocations to municipalities in the 2005/06 national financial year.

This is necessitated by the need to allocate funds from the disestablished Bohlabela district municipality (DM) to Ehlanzeni and Mopani District Municipalities as they became the successors-in-title of Bohlabela District Municipality.

This gazette therefore updates information that was originally published in Government Gazettes No. 27488 of 14 April 2005.

The government notice affects the following 2005/06 equitable share (schedule 3) allocations of Bohlabela, Ehlanzeni and Mopani District Municipalities as follows.

- Bohlabela district municipality's original allocation of R60,613 million is reduced by R19,574 million.
- Ehlanzeni district municipality original allocation of R3,564 million is increased by R16,016 million.
- Mopani district municipality original allocation of R92,810 million is increased by R3,557 million.

The affected municipalities are requested to effect adjustments to their projections of grant income from these programmes accordingly, through the passing of a municipal adjustments budget.
