MUNICIPAL DEMARCATION BOARD NOTICE IN TERMS OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 READ WITH SECTION 6 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (Government Gazette)

Following the withdrawal of the declaration of certain district management areas and the inclusion of those areas into the municipal areas of local municipalities published in Notice No. 1179, Government Gazette No.27806 of 18 July 2005, and Notice No. 2044, Government Gazette No. 28370 of 27 December 2005, the Municipal Demarcation Board hereby amends the Notice published in Government Gazette No. 21617 of 29 September 2000 as follows:

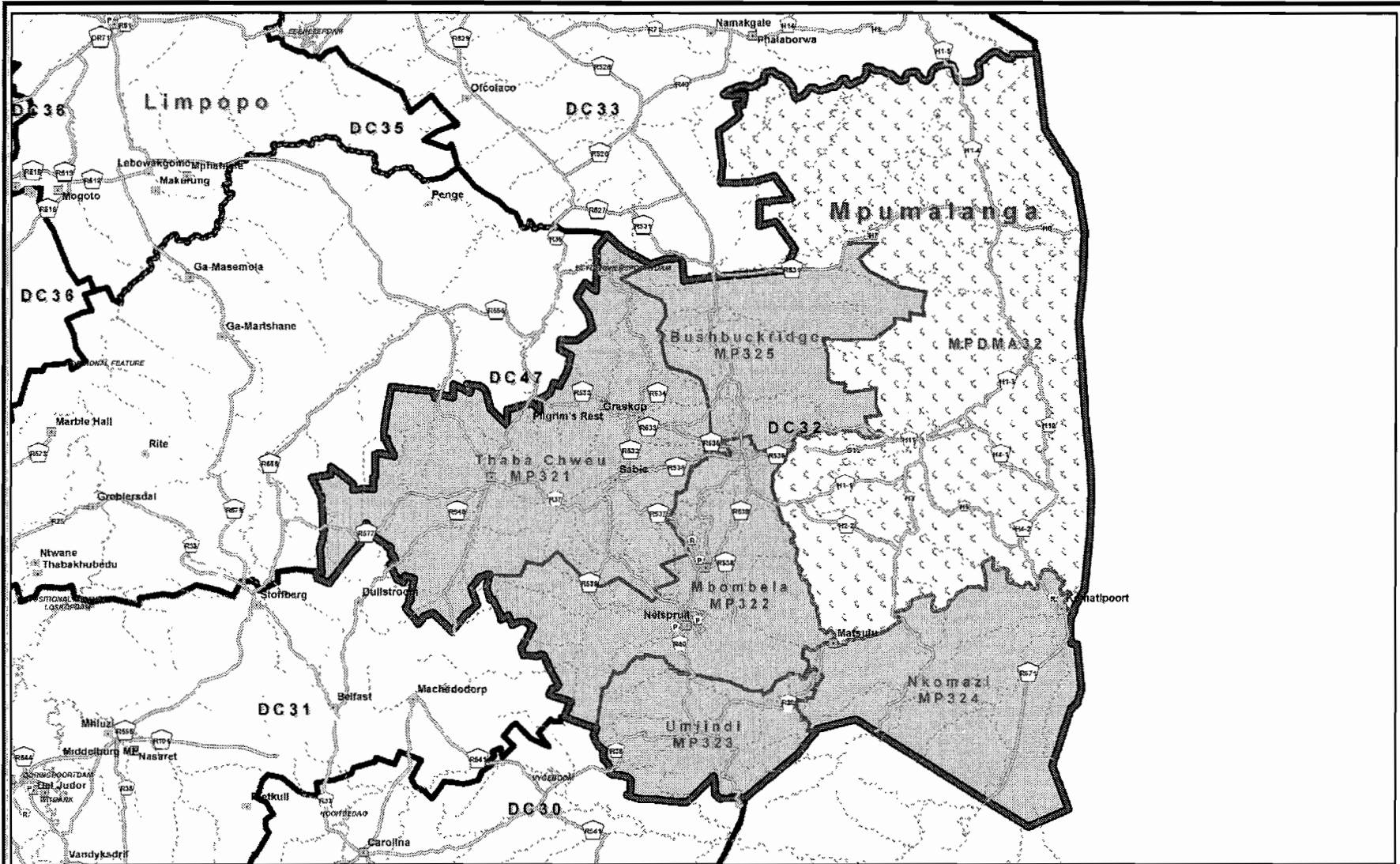

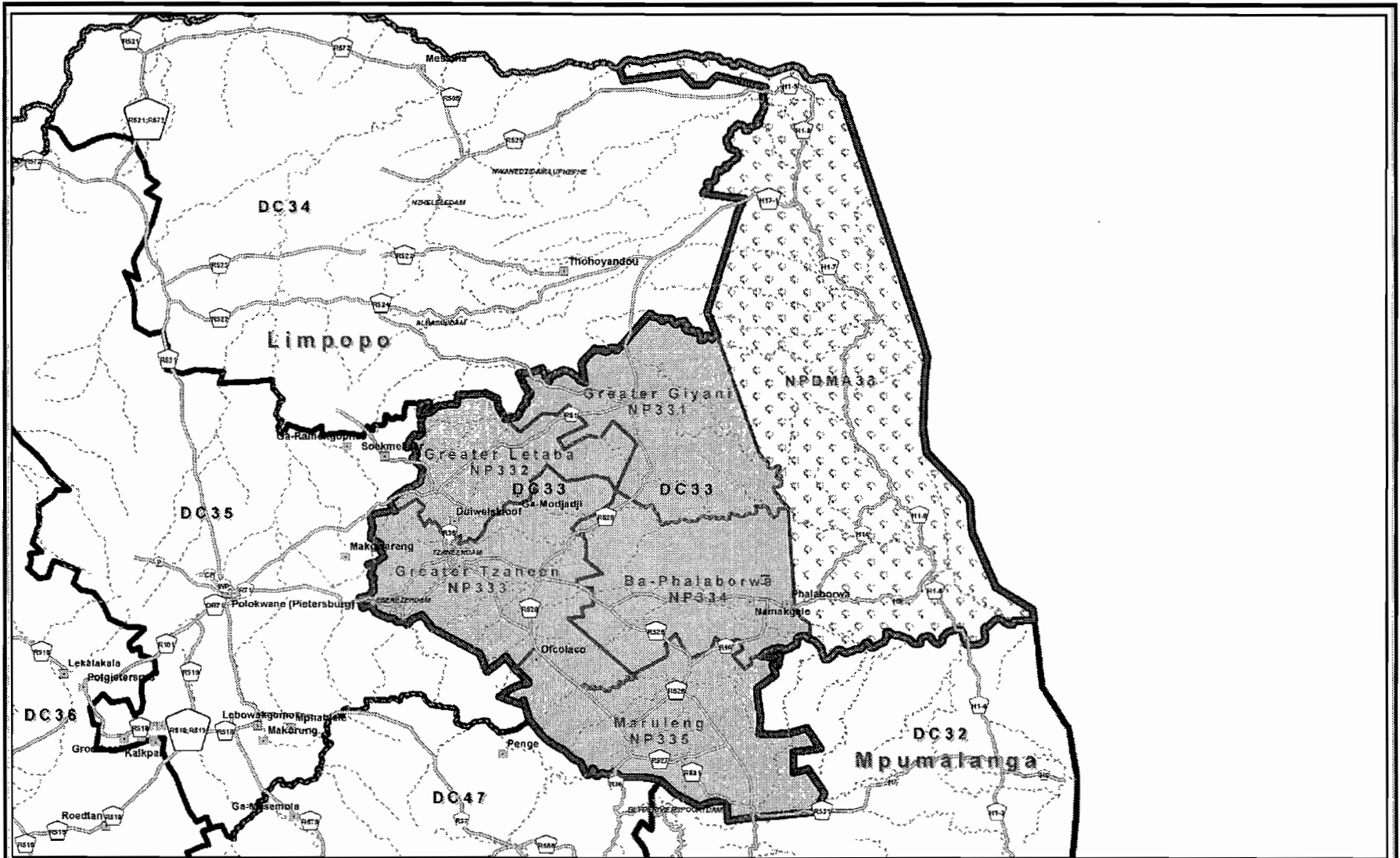
