Responsibilities of the regulator

When a nuclear accident has occurred and the regulator has defined the period and the area of the nuclear accident as contemplated in section 37(2)(b) of the Act the regulator must keep a record of each person who, according to its information, were within the area so defined at any time during the period so defined in the manner as specified in section 3.

Record of persons

3. A documented record of persons shall include but not be limited to the following, where applicable—

4. Failure to comply with these regulations shall constitute an offence as contemplated in section 52(2) of the Act.
