PUBLIC NOTICE BY ORGANISING FIELD 08, LAW, MILITARY SCIENCE AND SECURITY, TO RE- REGISTER A STANDARDS GENERATING BODY (SGB) FOR TRAFFIC, TRAFFIC RELATED AND LOCAL GOVERNMENT LAW ENFORCEMENT

The Directorate for Standards Setting and Development hereby re-registers the SGB for Traffic, Traffic Related and Local Government Law Enforcement for a period of three years from August 2006 to August 2009:

BRIEF OF THE SGB

1. Identify transformation, development, access and equity issues relevant to Traffic, Traffic Related and Local Government Law Enforcement and develop mechanisms to include these issues within the standards and qualifications as envisaged. *[Regulation 24(1)(e)]*.
2. Develop learning and career pathways for potential unit standards and qualifications for Traffic, Traffic Related and Local Government Law Enforcement. *[Regulation 24(1)(e)]*.
3. Generate unit standards and qualifications in accordance to SAQA requirements for Traffic, Traffic Related and Local Government Law Enforcement. *[Regulation 24(1)(a)]*.
4. Recommend the standards and qualifications generated and indicated in paragraph 3 above to Organising Field 08. *[Regulation 24 (1)(d)]*.
5. Recommend criteria for registration of assessors and moderators or moderating bodies. *[Regulation 24(1)(b)]*.
6. Review these unit standards and qualifications and effect the necessary changes. *[Regulation 24(1)(b)]*.
7. Perform such other related functions as may from time to time be requested by Organising Field 08. *[Regulation 24(1)(e)]*.
