APPLICATION FOR THE RENEWAL OF PRIVATE TELEVISION BROADCASTING LICENCE

MIDI TV (Pty) (Ltd)

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 44(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application from Midi TV (Pty) Ltd for the renewal of e.tv's private television broadcasting licence in terms of section 44(1) of the Act.
2. The effective date of the renewal would be the date on which the Authority's decision on the application would be published.
3. The application, relevant schedule and any representations received pursuant thereto is available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
4. Interested parties are invited to lodge written representations in relation to the application within thirty (30) days of the date of publication of this notice which will expire on 03 August 2006.
5. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.
6. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Bronwyn Keene-Young , Channel Director, e.tv, 5 Summit Road, Hyde Park, Johannesburg or sent by registered post at Private Bag X9944 Sandton or faxed to (011) 537 9301.

8. Midi TV (Pty) (Ltd) shall be entitled to respond in writing to written representations made by interested persons on the proposed renewal, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Midi TV (Pty) (Ltd) must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
