#### **CARRIAGE BY AIR AMENDMENT BILL, 2006**

The objects of the Bill are as follows:

To amend the Carriage by Air Act, 1946, (Act No.17 OF 1946), so as to insert certain definitions; to give effect to the International Convention for the Unification of Certain Rules for International Carriage by Air; to apply certain words contained in the said Convention; to extend the Minister's power to make regulations; and to replace the Schedule; and to provide for matters connected therewith.

The Minister of Transport intends introducing the Bill listed below into Parliament during August 2006

**CONVENTION ON THE INTERNATIONAL INTERESTS IN MOBILE  
EQUIPMENT AND THE PROTOCOL THERETO ON MATTERS  
SPECIFIC TO AIRCRAFT EQUIPMENT BILL, 2005**

The objects of the Bill are as follows:

To promote for the application in the Republic of the Convention on the International Interests in Mobile Equipment and the Protocol to the Convention on International Interests in Mobile Equipment on matters specific to Aircraft Equipment; to provide for the procedure to be followed with reference to ratification of additional Protocols to the Convention; to provide for the substitution of the Convention or Protocol if necessary; to authorize the Minister to make declarations, amendments to existing declarations or withdrawal of declaration, if necessary; and to provide for matters connected therewith.
