DECLARATION AMENDMENT OF NATIONAL ROAD N6 SECTIONS 7 AND 8

AMENDMENT OF DECLARATION NO. 548 OF 2003

By virtue of Section 40(1)(b) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), I hereby withdraw Declaration no. 548 of 2003 and by virtue of Section 40(1)(a) of the said Act, I hereby declare that **(I)** the section of Provincial Road P28 Section 2, also known as N6, commencing from a point on Smithfield Townlands 277 up to the intersection with Kerkhof Street, north of Reddersburg, **(II)** the section of Provincial road P54 Section 4, also known as N6, again commencing from a point on Reddersburg Townlands 291 up to the intersection with Provincial road P77 section 1 and **(III)** the section of Provincial road P77 Section 1, also known as N6 continuing from the intersection with Provincial road P54 Section 4 up to a point south of Bloemfontein on the farm Adelaide 2874 where it terminates as described in Annexure hereto, to be a National Road.

ANNEXURE**(I) Description of existing declared Provincial road P28/2 between Smithfield and Reddersburg)**

The section of route N6 also known as Provincial road P28 Section 2 as declared by Administrator's Notices no's 27 of 1961; 213 of 1961; 245 of 1972 and all other Administrator's Notices which are relevant to this section of road, commencing from a point on the farm Smithfield Townlands 277, immediately north of the surveyed erven, there from on proceeding in a general north-westerly direction on existing Provincial Road P28/2, up to the intersection with Kerkhof Street on the farm Reddersburg Townlands 291.

(II) Description of existing declared Provincial road P54/4 between Reddersburg and Bloemfontein

The section of route N6 also known as Provincial road P54 Section 4 as declared by Administrator's Notices no's 27 of 1961; 213 of 1961; 189 of 1968; 166 of 1971; 245 of 1972, 98 of 1994 and all other Administrator's Notices which are relevant to this section of road, again commencing from a point on the farm Reddersburg Townlands 291, being east of the furthest boundary beacons of Erven 534, there from on proceeding in a general northerly direction on existing Provincial road P54/4 up to the intersection with Provincial road P77/1 on the farm Fairview 1169.

(iii) Description of existing declared Provincial road P77/1 between the intersection with Provincial road P54/4 and National road N1/15.

The section of route N6, also known as Provincial road P77 Section 1 as declared by Administrator's Notice 135 of 1985 and all other Administrator's Notices which are relevant to this section of road, continuing from the intersection with Provincial road P54 Section 4 on the farm Fairview 1169 there from on proceeding in a general westerly direction on existing Provincial road P77/1 up to the junction with National Road N1 Section 15 as declared by Government Notice no.144 of 1979, South of Bloemfontein at the Sydenham interchange, where it terminates.

Kragtens Artikel 40 (1)(b) van die Suid Afrikaanse Nasionale Padagentskap Beperk en Nasionale Paaie Wet (Wet No. 7 van 1998), trek ek hiermee Verklaring no. 548 van 2003, terug en kragtens Artikel 40(1)(a) van genoemde Wet verklaar ek hiermee dat **(I)** die gedeelte van Provinsiale pad P28 Seksie 2, ook bekend as N6, beginnende vanaf 'n punt op die plaas Smithfield Townlands 277 tot die interseksie met Kerkhofstraat noord van Reddersburg, **(II)** die gedeelte van Provinsiale pad P54 Seksie 4, ook bekend as N6 beginnende weer vanaf 'n punt op Reddersburg Townlands 291 tot die interseksie met Provinsiale pad P77 Seksie 1 en **(III)** die gedeelte van Provinsiale pad P77 Seksie 1, ook bekend as die N6 voortgaan vanaf die interseksie met Provinsiale pad P54 Seksie 4 tot 'n punt suid van Bloemfontein op die plaas Adelaide 2874, waar dit eindig soos beskryf in aangehegte Bylae, as 'n Nasionale Pad.

(II) Beskrywing van bestaande verklaarde Provinsiale pad P54/4 tussen Reddersburg en Bloemfontein)

Die gedeelte van roete N6 ook bekend as Provinsiale Pad P54 Seksie 4 soos verklaar deur Administrateur Kennisgewings no's 27 of 1961; 213 of 1961; 189 van 1969, 166 van 1971, 245 van 1972, 98 van 1974 en alle ander Administrateur Kennisgewings wat van toepassing kan wees op hierdie gedeelte van pad, beginnende weer vanaf 'n punt oos van die verste grens bakens van Erf 534 op die plaas Reddersburg 291, daarvandaan verder gaan op die bestaande Provinsiale pad P54/4 in 'n algemene noordelike rigting tot die interseksie met Provinsiale pad P77/1 op die plaas Fairview 1169

(iii) Beskrywing van bestaande verklaarde Provinsiale pad P77/1 tussen die interseksie met Provinsiale pad P54/4 en die N1/15

Die gedeelte van roete N6 ook bekend as Provinsiale pad P77 Seksie 1 soos verklaar deur Administrateurs Kennisgewing no. 135 van 1985 en alle ander Administrateurs Kennisgewings wat van toepassing kan wees op hierdie gedeelte van pad, voortgaan vanaf die interseksie met Provinsiale pad P54 seksie 4 op die bestaande Provinsiale pad P77/1 in 'n algemene westelike rigting tot die aansluiting met Nasionale Pad N1 Seksie 15 soos verklaar deur Goewermentskennisgewing no 144 van 1979, suid van Bloemfontein by die Sydenham wisselaar, waar dit eindig.
