### NOMINATIONS FOR REPRESENTATIVES TO SERVE ON THE NATIONAL MALARIA ADVISORY GROUP

Nominations are invited from all interested persons (8 positions) who meet any of the requirements below; to serve on the national Malaria Advisory Group.

1. Clinical Medicine x 2 (with strong infectious diseases background)
2. Clinical Pharmacology x 1
3. Entomology x 2
4. Epidemiologist with disease control background
5. Research organisations x 2

Attention is drawn to the requirement that the members of the MAG, may hold office for a period of five years, as the Minister may determine at the time of appointment. A member of the MAG, excluding a member who is in the full-time employment of the State or the Service, must be appointed on such conditions, as the Minister may, with concurrence of the Minister of Finance, determine.

Nominations addressed for the attention of Dr MRB Maloba, Private Bag X828, Pretoria, 0001 or fax number (012) 312-3113, must be accompanied by

- (i) *curricula vitae*;
- (ii) the opinion of the nominator as to why the person/s nominated is/are fit to be so appointed, stating the grounds upon which such opinion is based;
- (iii) signed acceptance of the nomination by the nominee; and
- (iv) must be submitted not later than 31 October 2006.
