

NOTICE 5 OF 2007**INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF REVIEW OF THE ANTI-DUMPING DUTIES ON DOOR LOCKS AND DOOR HANDLES ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC)**

In accordance with the provisions of Article 11.3 of the World Trade Organisation Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade, any definitive anti-dumping duty shall be terminated on a date not later than five years from its imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the duty would be likely to lead to continuation or recurrence of dumping and injury.

On 26 May 2006, the Commission notified the South African Customs Union (SACU) industry through Notice No.673 in Government Gazette No.28847, that unless a substantiated request is made by it indicating that the expiry of the anti-dumping duties on the subject product originating in or imported from the People's Republic of China (PRC) would likely lead to the continuation or recurrence of dumping and injury, the anti-dumping duties on the subject product originating in or imported from the PRC will expire on 25 January 2007.

A response to the sunset review application questionnaire was received from the SACU industry on 24 August 2006.

THE APPLICANT

The application was lodged by ASSA ABLOY (SA) (PTY) LTD (the Applicant), being the producer of seventy per cent by production volume of the SACU industry. The Applicant alleges that the expiry of the duty would be likely to lead to continuation or recurrence of dumping and material injury. The Applicant submitted sufficient evidence and established a *prima facie case* to enable the Commission to arrive at a reasonable conclusion that a sunset review, investigation should be initiated.

THE PRODUCT

The products allegedly being dumped are door locks and door handles, classifiable under tariff subheading 8301.40, 8302.41.10 and 8302.41.90, originating in or imported from the PRC.

THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF DUMPING

The allegation of continuation or recurrence of dumping is based on the comparison between the normal values and the export prices.

The normal value for the PRC was based on the average ex-factory domestic price in India.

The Applicant used imports statistics supplied by SARS to calculate the export price. The FOB price was reduced by five percent in respect of internal transport from factory to harbour to calculate the ex-factory price.

On this basis, the Commission found that there was *prima facie* proof of the likely

recurrence of dumping if the duties expire.

THE ALLEGATION OF MATERIAL INJURY AND/OR THREAT OF MATERIAL INJURY

The Applicant alleges and submitted sufficient evidence to show that there is price undercutting and that the imports in question are depressing and suppressing its selling prices. The Applicant's information indicated that it would experience a decline in sales, profit margins, market share and capacity utilisation, if the duties expire. It also indicated an increase in inventories and is a negative effect on cash flow, return on investment, growth, and the ability to raise capital and employment, if the duties expire. It was also indicated that the Applicant's market share would decrease at the expense of a corresponding increase in the market share of the dumped goods, if the duties expire.

On this basis the Commission found that there was *prima facie* proof of the continuation and/or recurrence of material injury.

PERIOD OF INVESTIGATION

The period of investigation for purposes of determining the continuation or recurrence of dumping from the PRC will be from 1 April 2005 to 31 May 2006. The period of investigation for purposes of determining the continuation or recurrence of injury will be from 1 January 2002 to 31 May 2006. Any interested party may request an oral hearing at any stage of the investigation in accordance with Section 5 of the ADR, provided that the party indicates reasons for not relying on written submission only. The Commission may refuse an oral hearing if granting such hearing will unduly delay the finalisation of a determination. Parties requesting an oral hearing shall provide the Commission with a detailed agenda for, and a detailed version, including a non-confidential version, of the information to be discussed at the oral hearing at the time of the request.

If the required information and arguments are not received in a satisfactory form within the time limit specified above, or if verification of the information cannot take place, the Commission may disregard the information submitted and make a finding on the basis of the facts available to it.

**EXPLANATORY SUMMARY OF THE HOUSING CONSUMERS PROTECTION
MEASURES AMENDMENT BILL, 2007**

In accordance with Rule 241(1) of the Rules of the National Assembly –

1. The Minister of Housing herewith gives notice of the intention to introduce the Housing Consumers Protection Measures Amendment Bill, 2007 into Parliament.
2. The Housing Consumers Protection Measures Amendment Bill, which seeks to amend the Housing Consumers Protection Measures Act, 95 of 1998 (the Act), can be summarised as follows:
 - 2.1 The expressions “late enrolment”, “owner builder” and “PHP project” are defined, while the definitions “business of a home builder” and “home builder” is amended.
 - 2.2 The scope of application of the Act is clarified by the insertion of section 1A.
 - 2.3 The issue of “late enrolment” is substantiated and clarified with the amendment of sections 7(1), 16(6), 17(5) and the insertion of section 14A.
 - 2.4 Certain obsolete expressions are deleted.
 - 2.5 The position of so-called “owner builders” are clarified with the insertion of section 10A.
 - 2.6 The warranty provided for in the Act is extended to include roof leaks.

- 2.7 The authority to grant or refuse exemptions is vested in the National Home Builders Registration Council (the Council) whilst an appeal procedure against decisions of the Council is incorporated.
- 2.8 Section 21 of the Act, dealing with offences, is revised.
