

- 2. The annual fees payable by persons registering with council in terms of the Health Professions Act, 1974 (Act 56 of 1974) shall be a pro rata amount of the applicable annual fee referred to in rule 1, to be calculated according to the month of registration after the due date for payment of annual fees.
- 3. The annual fees prescribed in terms of these rules are inclusive of Value Added Tax (VAT).

4. The Rules published as Board Notice No 125 of 2005 under Government Gazette No. 28313 of 15 December 2005 are hereby repealed.
