NATIONAL ENERGY REGULATOR (NERSA) NOTICE IN TERMS OF SECTION 2(7) OF THE GAS REGULATOR LEVIES ACT 2002 (NO. 75 OF 2002)

Levy on Piped-Gas Industry

The Minister of Minerals and Energy with the concurrence of Minister of Finance has approved the budget and levies for the piped-gas industry in terms of section 2(4) of the Gas Regulator Levies Act No. 75 of 2002 as proposed by National Energy Regulator for 2006/07 financial year.

The levy for piped-gas is 35.75 c/GJ in respect of the amount of gas, measured in gigajoules, delivered by importers and producers to the inlet flanges of transmission or distribution pipelines and will be paid by the person holding the title to the gas at the inlet flange.

The levy was determined based on an estimated volume of 110 million GJ per annum and the 2006/07 Business Plan and Budget requirement, for the regulation of piped-gas industry, of R 39,326, 905 submitted to the Minister of Minerals and Energy.

The National Energy Regulator, acting under section 2(7) of the Gas Regulator Levies Act No. 75 of 2002, hereby publishes the 30 days notice on the imposition of the levies for piped-gas industry at 35.75 c/GJ for the 2006/07 financial year, as approved by the Minister of Minerals and Energy with the concurrence of the Minister of Finance.

The collection of the levy will be effective from 06 March 2007.
