APPLICATION FOR THE AMENDMENT OF BROADCASTING LICENCE CONDITIONS:

SEYALEMOYA COMMUNICATIONS (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 10 (2) of the Electronic Communications Act, No 36 of 2005, that it has received an application from Seyalemoya Communications Pty Ltd broadcasting as OFM Radio for the amendment to its licence in terms of section 10(1) of the Act.
2. The amendment is sought to enable Operator DeBeers Finsch Mine at Lime Acres to expand its existing Self-help station to include OFM Radio. The existing Self-help station is licenced to re-broadcast SABC1, 2, 3, e.tv, 5FM and Radio 2000.
3. The effective date of the amendment would be the date on which the Authority's decision on the application would be published.
4. The application, relevant schedule and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
5. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) days of the date of publication of this notice which will expire on 28 February 2007. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.
6. All written representations, responses and other correspondence in terms hereof must be directed to Ngoako Malatji at The Licensing Unit, Broadcasting Division, Independent Communications Authority of South Africa at Block D, Pinmill Farm, 164 Katherine Street, Sandton, Johannesburg or Private Bag x 10002 Sandton, 2146 or by fax no. 7. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Mr Lyndon Johnstone, Managing Director: OFM Radio, 1st Floor MTN Building, Nelson Mandela Drive, Bloemfontein or sent by registered post to PO Box 7117, Bloemfontein 9300 or by fax to (051) 505 0905.

8. Seyalemoya Communications (Pty) Ltd shall be entitled to respond in writing to written representations made by interested persons on the proposed amendment, and such written response must be lodged with the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. Seyalemoya Communications (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
