### THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL

#### REGULATIONS RELATING TO THE REGISTRATION OF DENTAL LABORATORIES AND RELATED MATTERS: AMENDMENT

The Minister of Health has, in terms of section 50 of the Dental Technicians Act, 1979 (Act No. 19 of 1979) on the recommendation of the South African Dental Technicians Council, made the regulations contained in the Schedule hereto.

#### SCHEDULE

##### Definition

1. In this Schedule "**the Regulation**" means the regulations published under Government Notice No. R. 308 of 26 February 1982, as amended by Government Notices Nos R. 1808 of 27 August 1982, R. 196 of 4 February 1983, R. 284 of 15 February 1985, R. 854 of 9 May 1986, R. 668 of 3 April 1987, R. 2440 of 2 December 1988, R. 2914 of 14 December 1990, R. 3156 of 27 December 1991, R. 107 of 22 January 1993, R. 434 of 11 March 1994, R. 194 of 10 February 1995, R. 134 of 2 February 1996, R. 14 of 3 January 1997, R. 1717 of 19 December 1997, R. 1685 of 24 December 1998, R. 8 of 7 January 2000, R. 1363 of 15 December 2000, R. 1321 of 14 December 2001 and R. 1489 of 29 November 2002, R. 468 of 8 April 2004, R. 1380 of 3 December 2004 and R. 1233 of 23 December 2005.

In this Schedule, "**the Act**" means the Dental Technicians Act, 1979 (Act 19 of 1979), and any expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates –

"**owner of a dental laboratory**" means the legal owner of a dental laboratory and shall include the person who is in charge of such dental laboratory or who conducts or supervises such dental laboratory.

##### Substitution of regulation 11 of the Regulations

2. The following regulation is hereby substituted for regulation 11 of the Regulations:

#### "REGISTRATION FEES"

11. (1) The registration fees for the registration of a dental laboratory under section 30 of the Act shall be R5818-00: Provided that if the ownership of a dental laboratory was changed or transferred in terms of section 30(6) of the Act, the registration fee payable for such a dental laboratory by the new owner shall be R3879-00.

- (2) The registration fee for a dental laboratory which is moved by the owner(s) to new premises shall be R1165-00: Provided that if the moving of such laboratory is due to factors beyond the control of the owner(s), such owner(s) shall pay only a registration fee of R582-00.
- (3) The registration fees referred to in sub-regulation (1) and (2) shall include 14% value-added-tax.

### **Substitution of regulation 12 of the Regulations**


3. The following regulation is hereby substituted for regulation 12 of the Regulations:

#### **“ANNUAL FEES”**

12. (1) Every owner/partner/member of a dental laboratory shall pay to the Council an amount of R2520-00 as an annual fee for the period 1 January to 31 December of each year or part thereof.
- (2) The amount referred to in sub-regulation (1) shall be due on 1 January of the year concerned and shall be payable not later than 31 January of that year.

### **Commencement**

4. These Regulations shall come into operation on 1 January 2007.

Die Minister van Gesondheid het, kragtens artikel 50 van die Wet op Tandtegnici, 1979 (Wet No. 19 van 1979), op aanbeveling van die Suid-Afrikaanse Raad vir Tandtegnici, die Regulasies in die Bylae uitgevaardig.

**BYLAE****Woordomskrywing**

1. In hierdie Bylae beteken **“die Regulasies”** die Regulasies afgekondig by Goewermentskennisgewing No. R.308 van 26 Februarie 1982, soos gewysig by Goewermentskennisgewings Nos. R.1808 van 27 Augustus 1982, R.196 van 4 Februarie 1983, R.284 van 15 Februarie 1985, R.854 van 9 Mei 1986, R.668 van 9 April 1987, R. 2440 van 2 Desember 1988, R. 2914 van 14 Desember 1990, R. 3156 van 27 Desember 1991, R. 107 van 22 Januarie 1993, R. 43 van 11 Maart 1994, R. 194 van 10 Februarie 1995, R. 134 van 2 Februarie 1996, R. 14 van 3 Januarie 1997, R. 1717 van 19 Desember 1997, R. 1685 van 24 Desember 1998, R. 8 van 7 Januarie 2000, R. 1363 van 15 Desember 2000, R. 1321 van 14 Desember 2001 en R. 1489 van 29 November 2002, R. 468 van 8 April 2004, R.1380 van 3 Desember 2004 en R.1233 van 23 Desember 2005.

In hierdie Bylae beteken **“die Wet”** die Wet op Tandtegnici, 1979 (Wet 19 van 1979), en het enige uitdrukking waaraan 'n betekenis in die Wet geheg is, daardie betekenis en tensy uit die samehang ander blyk beteken –

**“eienaar van 'n laboratorium vir tandkundige werk”** die wettige eienaar van 'n laboratorium vir tandkundige werk, en ook die persoon wat in beheer is van sodanige laboratorium of wat dit bedryf of toesig daarvoor hou.

**Vervanging van regulasie 11 van die Regulasies**

2. Regulasie 11 van die Regulasies word hierby deur die volgende regulasie vervang:
  11. (1) Die registrasiegelde vir die registrasie van 'n laboratorium vir tandkundige werk ingevolge artikel 30 van die Wet is R5818-00: Met dien verstande dat indien die eiendomsreg van 'n laboratorium vir tandkundige werk verander of oorgedra is ingevolge artikel 30(6) van die Wet, die registrasiegelde betaalbaar deur die nuwe eienaar vir sodanige laboratorium vir tandkundige werk R3879-00 is.

- (2) Die registrasiegelde vir 'n laboratorium vir tandkundige werk wat deur die eienaar(s) na 'n nuwe perseel verskuif is, is R1165-00: Met dien verstande dat indien die verskuiwing van sodanige laboratorium te wyte is aan faktore buite die beheer van die eienaar(s), moet sodanige eienaar(s) registrasiegelde van slegs R582-00 betaal.
- (3) Die registrasiegelde in subregulasies (1) en (2) bedoel, sluit 14% belasting op toegevoegde waarde in."

### **Vervanging van Regulasies 12 van die Regulasies**

3. Regulasies 12 van die Regulasies word hierby deur die volgende Regulasies vervang:
  12. (1) Elke eienaar/vennoot/lid van 'n laboratorium vir tandkundige werk betaal aan die Raad 'n bedrag van R2520-00 as jaarlikse gelde vir die tydperk 1 Januarie tot 31 Desember van elke jaar of 'n gedeelte daarvan.
  - (2) Die bedrag in subregulasie (1) bedoel, is verskuldig op 1 Januarie van die betrokke jaar en is betaalbaar nie later nie as 31 Januarie van daardie jaar.
  - (3) Die bedrag in subregulasie (1) bedoel, sluit 14% belasting op toegevoegde waarde in."



**THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL****NOTICE REGARDING ANNUAL FEES PAYABLE TO THE COUNCIL**

I, Mantombazana Edmie Tshabalala-Msimang, Minister of Health, hereby fix, in terms of section 49 of the Dental Technicians Act, 1979 (Act No. 19 of 1979), and on the recommendation of the South African Dental Technicians Council (hereinafter referred to as "the Council"), the fees set out in the Schedule as the fees to be paid to the Council.

**SCHEDULE****Annual fees payable by dental technicians and dental technologists**

1. Any person who, in terms of section 18 of the Dental Technicians Act, 1979 (Act No. 19 of 1979) –
  - (a) is registered, shall pay to the Council an amount of R630-00 as an annual fee for the period 1 January to 31 December of each year; or
  - (b) is registered during such period shall pay to the Council an amount of R315-00 as an annual fee in respect of the unexpired portion of that year.

**Annual fees payable by permit holders for trading in unmounted artificial teeth**

2. Any person who, in terms of section 33(3) of the Dental Technicians Act, 1979 (Act No. 19 of 1979) –
  - (a) is issued with a permit by the Council, shall pay to council an amount of R 1 432 as an annual fee for the period 1 January to 31 December of each year; or

- (b) is issued with a permit by the Council during such period shall pay to the council an amount of R716-00 as an annual fee in respect of the unexpired portion of that year.

### **Liability**

#### **3. The annual fees referred to in-**

- (a) paragraphs 1(a) and 2(a) shall be due on 1 January of the year concerned shall be payable not later than 31 January of that year; and
- (b) paragraphs 1(b) and 2(b) shall be due on the day of the registration concerned or the permit is issued, as the case may be, and shall be payable on or before the last day of the third month following that day, or on 31 December of that year, whichever date is the earlier.

- 4. (1) If a person referred to in paragraphs 1 and 2, as the case may be, does not pay the annual fees referred to in the aforementioned paragraphs by the relevant date referred to in paragraph 3, the registrar shall send a reminder by e-mail and/or registered post to such dental technician's or the permit holder's address, as the case may be, as entered in the register.

- (2) If a person referred to in paragraphs 1 and 2 does not pay the annual fees within three (3) months after the date on which the reminder referred to in subparagraph(1) was sent to him or her, his or her name shall be removed from the register concerned in terms of section 24(1) or the permit be withdrawn in terms of section 33(4) of the Act as the case may be.

- 5. (1) A person referred to in paragraph 4 whose name has been removed from the register concerned or whose permit has been withdrawn, may be restored to such register in terms of section 24(5) of the Act, or his permit be restored, if such person-

- (a) within a period of six (6) months after the date on which his or her name was removed from the register concerned, pays the equivalent of two (2) times the annual fee referred to in paragraph 1(a) or 2(a), including any other outstanding fee(s); or
- (b) after a period of six (6) months has expired after the date on which his or her name was removed from the register concerned, pays the equivalent of five (5) times the annual fee referred to in paragraph 1(a) or 2(a), including any other outstanding fee(s).



**Exemption**

6. (1) The Council may by resolution, order the Registrar to exempt any dental technician or dental technologist for an indefinite or definite period, from the age 70 years from payment of any annual fee prescribed in terms of paragraph 1, if the Council is satisfied that such a dental technician or dental technologist-
- (a) has a written application by way of an affidavit accompanied by a certified copy of a valid identity document, before 31 December preceding the year for which exemption is sought or applied for, and
  - (b) has attained the age of 70 years; and
  - (c) has paid the prescribed fee of R220-00

**Value added tax**

7. All fees referred to in the notice shall include 14% value-added tax.

**Commencement**

8. This notice shall come into operation on 1 January 2007.

**Withdrawal of notice**


9. Government Notice No. R28247 of 25 November 2005 is hereby withdrawn.

  - (a) geregistreer is, betaal aan die Raad 'n bedrag van R630-00 as jaarlikse gelde vir die tydperk 1 Januarie tot 31 Desember van elke jaar; of
  - (b) gedurende genoemde tydperk geregistreer word, betaal aan die Raad 'n bedrag van R315-00 as jaarlikse gelde ten opsigte van die onverstreke gedeelte van daardie jaar.

**Jaarlikse gelde betaalbaar deur permit houers wat handeldryf in ongemonteerde kunstende**

2. Enige persoon, kragtens artikels 33 (3) van die Wet of Tandtegnici, 1979 (Wet No 19 van 1979)-
  - (a) aan wie in 'n permit deur die Raad uitgereik is, sal aan die Raad 'n bedrag van R1 432-00 as jaarlikse gelde vir die periode 1 Januarie tot 31 Desember van elke jaar betaal; of
  - (b) as 'n permit deur die Raad uitgereik word gedurende sodanige periode, sal 'n bedrag van R 716-00 as jaarlikse gelde aan die Raad betaalbaar wees, vir die onverstreke gedeelte van daardie jaar.

**Aanspreeklikheid**

3. Die jaarlikse gelde in-
  - (a) paragraaf 1(a) en 2(a) is verskuldig op 1 Januarie van die betrokke jaar en is betaalbaar nie later nie as 31 Januarie van daardie jaar, en
  - (b) paragraaf 1(b) en 2(b) is verskuldig op die dag van die betrokke registrasie of waarop die permit uitgereik is, na gelang van die geval, en is betaalbaar voor of op die laaste dag van die derde maand wat op daardie dag volg, of op 31 Desember van daardie jaar, welke datum ook al die vroegste is.
4. (1) Indien 'n persoon in paragraaf 1 en 2 bedoel, na gelang van die geval, nie die jaarlikse gelde in die voormelde paragrawe vermeld, teen die datum in paragraaf 3 bedoel, betaal nie, moet die registrateur 'n aanmaning per e-pos en/of aangetekende pos aan sodanige tandtegnikus of permithouer, wat die geval ook mag wees, se adres wat in die register aangeteken is, stuur.  
(2) Indien 'n persoon in paragraaf 1 en 2 bedoel nie die jaarlikse geld binne (3) drie maande na die datum waarop die aanmaning bedoel in subparagraaf (1) aan hom of haar gestuur is, betaal nie, moet sy of haar naam van die betrokke register geskrap word ingevolge artikel 24(1) van die Wet of die permit onttrek word ingevolge artikel 33 (4) van die Wet, wat die geval ook mag wees.
5. (1) 'n Persoon in paragraaf 4 bedoel, wie se naam geskrap is van die betrokke register, of wie se permit onttrek is, kan kragtens artikel 24(5) van die Wet op sodanige register teruggeplaas word, of sy permit kan weer uitgereik word, indien sodanige persoon-
  - (a) binne 'n periode van ses (6) maande na die datum waarop sy of haar naam uit die betrokke register geskrap is, die ekwivalent van twee (2) keer die jaarlikse geld in paragraaf 1(a) of 2 (a) bedoel, insluitend enige ander uitstaande gelde, betaal; of
  - (b) nadat 'n periode van ses (6) maande verstryk het, na die datum waarop sy of haar naam uit die betrokke register geskrap is, die ekwivalent van vyf (5) keer die jaarlikse geld in paragraaf 1(a) of 2 (a) bedoel, insluitend enige ander uitstaande gelde, betaal.

**Vrystelling**

6. (1) Die Raad kan, by besluit, die Registrateur opdrag gee om enige tandtegnikus of tandtegnoloog vanaf 70 jarige ouderdom vir 'n onpepaalde of bepaalde tyd, vry te stel van betaling van die voorgeskrewe jaarlikse gelde, kragtens paragraaf 1, as die Raad tevrede is dat sodanige tandtegnikus of tandtegnoloog-
  - (a) 'n skriftelike aansoek het, by wyse van 'n beedigde verklaring, wat vergesel is van 'n gesertifiseerde afskrif van 'n geldige identiteitsdokument, voor 31 Desember van die voorafgaande jaar waarvoor vrystelling aansoek gedoen word; en
  - (b) reeds 70 jaar is; en
  - (b) wat die voorgeskrewe bedrag van R 220-00 betaal het.

**SCHEDULE****Definitions**

1. In these regulations, any word or expression to which a meaning has been assigned in the Act shall have meaning so assigned and, unless the context otherwise indicates –

“**professional board**” means the Professional Board for Radiography and Clinical Technology established in terms of section 15(1) of the Act, as published under Government Notice No. R. 75 of 16 January 1998; and

“**the Act**” means the Health Professions Act, 1974 (Act No. 56 of 1974).

**Categories for registration**

2. Any person who satisfies the registrar that he or she complies with the requirements set out in regulation 3 may be registered in one or more of the following:

Cardiology

Cardiovascular Perfusion

Critical Care

Nephrology



**SCHEDULE****1. Definitions**

In this Schedule any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates –

“**board**” means the Professional Board for Radiography and Clinical Technology established in terms of section 15(1) of the Act, as published by Government Notice No. R.75 of 16 January 1998;

“**examination**” means an examination conducted by an educational institution approved by the board or an examiner appointed by the board;

**“independent practice”** means the practicing of the profession of radiography by a radiographer without being supervised by another health professional, but not in private practice;

**“private practice”** means the practising of the profession of radiography by a radiographer for his or her own account, either in *solus* practice, or as a partner in a partnership, or as an associate in an association with other practitioners, or as a director of a company established in terms of section 54A of the Act;

**“public service”** means a service rendered by the State at the national, provincial and local level of government, and includes organizations with function under the auspices or are largely subsidized by the State or recognized by the professional board for the purpose of these regulations;

**“radiographer”** means a person registered as such in terms of the Act; and

**“the Act”** means the Health Professions Act, 1974 (Act No. 56 of 1974).

## **2. Registration as a radiographer in the categories diagnosis, therapy, nuclear medicine or ultrasound**

(1) The registrar may register as a radiographer in the category diagnosis, therapy, nuclear medicine or ultrasound any person who has obtained, after examination, a qualification referred to in subregulation (2) in the category concerned: Provided that -

(a) no qualification must be accepted unless the training to obtain such qualification has extended over a minimum period of two years and provided further that in the case of a qualification obtained subsequent to 31 December 1984 the period of two years must be increased to three years;

(b) a person who is registered with the council in any one of the categories diagnosis, therapy, nuclear medicine or ultrasound and who subsequently obtained by examination, in another one of such

categories, a qualification referred to in subregulation (2), may also be registered in such other category;

- (c) every person who, prior to 6 March 1959, was registered with the council as a radiographer under the provisions of Government Notice No. 1554 of 22 September 1944, as amended, must be deemed to be registered in the categories of diagnosis and therapy;
- (d) every person who, prior to 16 September 1977, was registered with the council as a diagnostic radiographer or a therapeutic radiographer or both, must be deemed to be registered in the category of diagnosis or therapy, or both, as the case may be;
- (e) every person who, prior to 1 January 1994, was registered with the council as a radiographer in the category diagnosis must be deemed to be registered in the category of diagnosis or ultrasound, or both, as the case may be.
- (2) A person referred to in subregulation (1) who holds one of the following qualifications may apply to the registrar for registration as a radiographer in the category concerned in terms of section 17 of the Act:



### 3. Registration categories for the registration of radiographers

- (1) The registrar may register a person who holds a qualification referred to in regulation 2(2) as a radiographer in any one of the following categories:
  - (a) Independent practice;
  - (b) private practice; and
  - (c) public service.
  
- (2) The registrar may register a person as a radiographer in the category independent practice if such person –
  - (a) holds a qualification referred to in regulation 2(2); or

- (b) has satisfactorily completed community service in terms of section 24A of the Act.
- (3) The registrar may register a person as a radiographer in the category private practice if such person –
- (a) holds a qualification referred to in regulation 2(2); and
  - (b) has completed a minimum period of two years practical experience in the category independent practice or public service.
- (4) The registrar may register a person as a radiographer in the category public service if such person –
- (a) holds a qualification referred to in regulation 2(2); and
  - (b) performs community service in terms of section 24A in terms of the Act.
