**NOTICE 388 OF 2007****DEPARTMENT OF EDUCATION****NATIONAL EDUCATION POLICY ACT 27 OF 1996**

## **Requirements for the administration of surveys**

### Requirement 1:

*Every Provincial Education Department (PED) must administer an annual census form for 3 years and a full census form every 4<sup>th</sup> year starting in 2009 for each of the types of institutions listed hereunder.*

No	Institutions
1.1	Public Adult Basic Education and Training centres, established in terms of the ABET Act, 2000 (Act No. 52 of 2000)
1.2	Early Childhood Development centres, registered in terms of the applicable provincial Acts
1.3	Further Education and Training colleges, established in terms of the Further Education and Training Colleges Act of 2006
1.4	Ordinary schools, established in terms of the South African Schools' Act, 1996 (Act No. 84 of 1996)
1.5	Special schools, established in terms of the South African Schools' Act, 1996 (Act No. 84 of 1996)

### Requirement 2:

*The content, structure and format of the census forms that will be utilised for the relevant institutions listed hereunder, will be that content, structure and format, which has been approved by Heads of Education Committee (HEDCOM):*
