## B I L L

To amend the Air Services Licensing Act 115,1990, so as to allow for the Minister of Transport to designate the Chairperson and Deputy Chairperson of the Domestic Air services Council.

BE IT ENACTED by the Parliament of the Republic of South Africa, as

follows: -

Amendment of section 1 of Act 115 of 1990

1. Section 1 of the principal Act is hereby amended by the insertion after the definition of "air service" of the following definition:

"appointed member" means a member of the council appointed by the minister in terms of section 4(1)(c);

## Amendment of section 4 of Act 115 of 1990

2. Section 4 of the principal Act is hereby amended-

2.1 by the substitution for paragraphs (a), (b) and (c) of subsection (1) of the following paragraphs:

Section 4(1) The members of the council shall consist of-

(a) "a person designated by the Minister as Chairperson; "

(b) "a person designated by the Minister from the appointed members as vice-chairperson; and

(c) "not more than [three] four other persons appointed by the Minister, who have appropriate knowledge and experience regarding aviation, or who are well versed in law, finance, transportation or engineering. "

## Amendment of section 6 of Act 115 of 1990

### Disqualification for membership of council

3. Section 6 of the principal Act is hereby amended-

3.1 by substitution for subsection (1) of the following subsection:

(1) " No person shall be appointed as [a] an appointed member of the council if he-

### Short title

4. This Act is the Air Services Licensing Amendment Act, 1990, and takes effect on a date determined by the President by Proclamation in the *Gazette*.
