SERVICE LICENCE RECEIVED FROM RADIO PULPIT**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of clause 4.1 of the Community Sound Broadcasting Services regulations published on 6 June 2006, read with section 95 (1) and (2) of the Electronic Communications Act 35 of 2006, that it has received an application for a community sound broadcasting service licence from Radio Pulpit. The details of the applications are contained in the schedule below.
2. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.
3. Interested persons are invited to lodge written representations in relation to the application by no later than 31 July 2007. 4. Persons who lodge representations in terms hereof, must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority should there be a hearing convened

5. Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Dr. Roelf Petersen at Radio Pulpit, 42 Jacobus Street, Kilner Park, Pretoria, or sent by registered post to P.O. Box 3436, Pretoria 0001 or faxed to (012) 333 7251.
6. Radio Pulpit shall be entitled to respond in writing to written representations made by interested persons on the application, and such written response must be lodged with the Authority within thirty (31) days of the date of publication of this notice in the *Government Gazette*. Radio Pulpit must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
