

## PROPOSAL BY ROAD ACCIDENT FUND TO IMPLEMENT DIRECT PAYMENT SYSTEM

On 11 March 2007, the Road Accident Fund ("the RAF") invited members of the public and all stakeholders to submit comments on a proposal to introduce a direct payment system 'DPS' to suppliers of medical and related services and injured persons. The RAF has received and considered submissions and comments from various representative bodies of the organized legal profession, individual firms of attorneys and members of the public regarding DPS. After careful consideration of the submissions and as part of its commitment to improve service delivery and reduce fraud and corruption, the RAF proposes that it introduces a system to pay claimants directly.

The proposed implementation plan for DPS is as follows:

## 1. IMPLEMENTATION DATES OF DPS

The DPS will be introduced in planned and structured phases as follows:

<b>2. Payments to claimants resulting from personal injury or death</b>	
Compensation due by RAF in excess of R1 million	5 November 2007

## 2. PAYMENT OF COMPENSATION (CAPITAL)

On finalization of a claim either by way of settlement, a court order or arbitration award, the capital amount (compensation) due by the RAF will be paid directly to the claimant. This will apply to all claims that have been lodged with the RAF and to all claims that in future will be lodged with the RAF.

## 3. PAYMENT OF COSTS
