DEFINITIONS

- I. In these regulations, "the Regulations" means the regulations published by Government Notice No. R.1 754 of 2 Decembel' 2003.

AMENDMENT OF REGULATION 2 OF THE REGULATIONS

2. Regulation 2 is hereby amended by the substitution for regulation 2 of the following regulation:
- "2. The Council will be responsible for the issuing of the following certificates:
- (a) Senior Certificate;
 - (b) National Senior Certificate;
 - (c) National Certificate N3;
 - (d) General Education and Training Certificate;
 - (e) Further Education and Training Certificate;
 - (f) Subject certificate;
 - (g) Learning area certificate; lor]
 - (h) Unit certificatej.];
 - (i) National Certificate (Vocational): A qualification at Level 2 on the NQF;
 - (i) National Certificate (Vocational): A qualification at Level 3 on the NOF;
 - (k) National Certificate (Vocational): A qualification at Level 4 on the NOF."

AMENDMENT OF REGULATION 2 OF THE REGULATIONS

3. Regulation 15 is hereby amended by the substitution for regulation 15(a), as amended by the Amendment Regulations for the Issuing of Certificates by the Council, 2004, of the following:

“(a) The format of certificates referred to in Regulation 2 will be as contemplated in Appendices B to [I] appended hereto, provided that- ”.

SHORT TITLE AND COMMENCEMENT

4. these Regulations may be cited as the Amendment Regulations for the Issuing of Certificates by the Council, 2007. The National Certificate (Vocational): A qualification at Level 2 on the NQF will come into effect on 1 January 2007, the National Certificate (Vocational): A qualification at Level 3 on the NQF will come into effect on 1 January 2008, and the National Certificate (Vocational): A qualification at Level 4 on the NQF will come into effect on 1 January 2008 will come into effect on 1 January 2009.
