MINISTERIAL COMMITTEE TO DRAFT A GREEN PAPER ON A REVAMPED ADULT EDUCATION AND TRAINING SYSTEM FOR SOUTH AFRICA

I, Grace Naledi Mandisa Pandor, Minister of Education, in terms of section 20.2 and 20.3 of the Public Finance Management Act, 1999: hereby establishes a Ministerial Committee to draft a Green Paper on a revamped Adult Education and Training System for South Africa.

TERMS OF REFERENCE

The terms of reference of the Committee are as follows:-

- a) To draft the Adult Education and Training Green Paper for the Minister's consideration.
- b) To investigate the nature, structure, content and relevance of the new Adult Education and Training qualifications and make recommendations after examining the following:
 - (i) the current Institutional landscape;
 - (ii) the existing qualification and its relevance;
 - (iii) the need to consider articulation between programmes that relate to Basic Literacy, Formal Basic Education for Adults, Post basic education as well as Skills Based Programmes;
 - (iv) Adult Educator qualifications, provision and conditions of service; and
 - (v) Financing of the current basic education for adults.

- c) To consider the legal implications for a new Adult Education and Training system, with particular regard to the current ABET Act (Act No. 52 of 2000).
- d) To make recommendations on relevant programmes to be offered by the Department of Education. This will include appropriate providers for such programmes considering the current and a possibly expanded institutional landscape.
- e) To review relevant international reports on adult education and lifelong learning in making recommendations about a revamped AET system.


