### **APPLICATION FOR THE AMENDMENT OF COMMUNITY SOUND BROADCASTING LICENCE CONDITIONS: KANGALA COMMUNITY RADIO**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 10(2) of the Electronic Communications Act, No. 36 of 2005, that it has received an amendment application from Kangala Community Radio ("the licensee") for the amendment to its licence conditions in terms of section 10(1) of the Act.
2. The amendment application seeks to enable the licensee to install a second transmitter in the Kwaggafontein area using 98.7 MHz with an ERP of 1000 Watts.
3. Should the Authority approve the application, the effective date of the amendment would be the date on which the Authority's decision on the application is published.
4. The application and any representations received pursuant thereto would be made available and be open for inspection by interested parties in the Authority's library during normal office hours.
5. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) days of the date of publication of this notice which will expire on 10 December 2007. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations should the Authority decides to hold public hearings.
6. All written representations, responses and other correspondence in terms hereof must be directed to Ngoako Malatji, Licensing Unit, Broadcasting Division, Independent Communications Authority of South Africa, Block D, Pinmill Farm, 164 Katherine Street, Sandton, Johannesburg or Private Bag x 10002 Sandton, 2146 or by fax on 011 448 2186.

7. Persons who lodge representations in terms hereof, shall at the time of lodgment furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Celimpilo Masondo, Kangala Community Radio, 1373 Section D, Ekangala 1021 or sent by registered post to P.O. Box 119 Ekangala, 1021, or by fax 013 934 8673.
8. The licensee shall be entitled to respond in writing to written representations made by interested persons on the proposed amendment, and such written representations must be lodged with the Authority within thirty (30) days of the date of publication of this notice in the Government Gazette. The licensee must, at the time of lodging such written response, furnish proof to the satisfaction of the Authority that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person who made such written representations.
