#### DEPARTMENT OF AGRICULTURE

### PUBLICATION OF EXPLANATORY SUMMARY OF THE LIQUOR PRODUCTS AMENDMENT BILL, 2008

I, Lulama Xingwana, Minister of Agriculture hereby intend to introduce the Liquor Products Amendment Bill in the National Assembly during 2008. The explanatory summary of the Bill is hereby published in accordance with Rule 241 (1) (c) of the Rules of the National Assembly.

The Bill addresses the following issues:

The amendment of the Liquor Products Act, 1989, so as to insert definitions and to amend and delete others; to provide for the composition of the Wine and Spirit Board; to amend the requirements regarding wine; to extend the particulars required in connection with the sale of liquor products in containers; to empower the Minister to prohibit the use of geographical names under certain circumstances; to make other provisions for the establishment of schemes; to curtail the board's power regarding the import and export of liquor products; to provide for compliance with international obligations; to extend the Minister's power to make regulations; and to provide for matters connected therewith.

**KENNISGEWING 614 VAN 2008****DEPARTEMENT VAN LANDBOU****PUBLIKASIE VAN VERDUIDELIKENDE OPSOMMING VAN DIE WYSIGINGSWET  
OP DRANKPRODUKTE, 2008**

Ek, Lulama Xingwana, Minister van Landbou, beoog om die Wysigingswet op Drankprodukte bekend te stel by die Nasionale Vergadering gedurende 2008. Die verduidelikende opsomming van die Wysigingswetontwerp word hiermee gepubliseer ooreenkomstig Reël 241 (1) (c) van die Reëls van die Nasionale Vergadering.

Die wetsontwerp dek die volgende aangeleenthede:

Die wysiging van die Wet op Drankprodukte om definisies in te sluit, wysig of ander weg te laat om voorsiening te maak vir die samestelling van die Wyn en Spiritusraad; om die besonderhede uit te brei wat nodig is in verband met wyn; om die besonderhede uit te brei in verband met die verkope van drankprodukte in houers; om die Minister te bemagtig om die gebruik van geografiese name onder sekere toestande te verbied; om ander voorsienings te maak vir die stigting van skemas; om die raad se magte te beperk rakende die invoer en uitvoer van drankprodukte; om te voorsien vir die nakoming van internasionale verpligtinge; om die Minister se magte uit te brei om regulasies uit te vaardig; en om te voorsien vir verwante sake.
