**WARRANT**

By the President of the Republic of South Africa by which the

**“Municipal/Metropolitan Police Service Gold Cross for Bravery”**

is instituted

**To all to whom these presents may come:**

**Greetings!**

Whereas it is deemed desirable to recognize signal acts of bravery displayed by members of Municipal/Metropolitan Police Services who, in the discharge of their functions or in protecting or saving property or life, have lost or genuinely imperilled their own lives;

And whereas it is deemed expedient to honour such members in a fitting manner;

Now, therefore, by virtue of the powers granted to me to confer honours in accordance with the provisions of *Section 84(2) of the Constitution of the Republic of South Africa, 1996, read together with Sections 44(2) & 64O of the South African Police Service Act, 1995 (Act No. 68 of 1995), Regulation 9 (Annexure 5) of the Regulations for Municipal Police Services as promulgated in Government Gazette No. 20142 dated 11 June 1999 and the Regulations for Municipal (Metropolitan) Police Services regarding Medals and Decorations as promulgated in Government Gazette No. 30523 dated 4 December 2007*, I do hereby institute a new decoration in recognition of acts of exceptional bravery by members of Municipal/Metropolitan Police Services, and further ordain that the following Rules as may be made under this Warrant, shall govern the award of this decoration:

**1. PRECEDENCE:**

The decoration shall take precedence over any other decoration or medal, which may be awarded exclusively to members of a Municipal/Metropolitan Police Service, and also holds the position in the official table of precedence, as determined by the Presidency from time to time.

**2. DESCRIPTION:**

- Obverse: The decoration shall be in the form of a gold cross paty nowy, charged in the centre with a blue roundel thereupon and a full laurel wreath surrounding a five pointed faceted star, all gold.
- Reverse: The national coat of arms of the Republic of South Africa, and there above, the semi circular inscription, FORTES FORTUNA JUVAT.
- Size: 40mm across.
- Suspension: Pendant from a plain suspender fixed to the upper arm of the cross and hanging from a breast ribbon.

**3. RIBBON:**

The Municipal/Metropolitan Police Service Gold Cross for Bravery shall be a pendant from a ribbon 32mm wide: 2mm red, 2mm white, 10mm blue, 4mm gold, 10mm blue, 2mm white, 2mm red.

**4. BAR:**

A bar may be awarded in terms of rule 6, and shall be of silver gilt, 6mm wide and 34mm in length, bearing a five-pointed faceted silver gilt star with a diameter of 10mm. For each subsequent award, the bar shall bear an additional five-pointed faceted silver gilt star.

**5. CONFERMENT REQUIREMENTS DECORATION:**

A decoration may be awarded to a member of a Municipal/Metropolitan Police Service who has distinguished himself or herself by performing an exceptional deed of bravery in extremely dangerous circumstances.

**6. CONFERMENT REQUIREMENTS BAR:**

A bar may be awarded to any member of a Municipal/Metropolitan Police Service to whom this decoration has already been awarded and who, subsequent to such award and while still serving as a member of a Municipal/Metropolitan Police Service, has again distinguished himself or herself in the manner described in rule 5.

In respect of every such additional distinction, a bar may be awarded: Provided that a bar shall be awarded only to a member who is already in possession of the decoration, otherwise an appropriate decoration shall be awarded and not a bar.

**7. CONFERMENT, FORFEITURE OR RESTORATION OF DECORATION:**

The decoration, as well as the bar in respect thereof, shall be awarded by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of a Municipal/Metropolitan Police Service and may also be cancelled, annulled, declared forfeited or restored by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, subject to such conditions as may be prescribed by the Regulations.

**8. POSTHUMOUS AWARD:**

The decoration as well as the bar in respect thereof, may be awarded posthumously.

**9. ENGRAVING OR STAMPING OF SERIAL NUMBER:**

On the reverse of each decoration awarded shall be engraved or stamped a serial number that is linked to the service number of the recipient.

**10. PUBLICATION IN DISTRIBUTION LIST & RECORDING IN REGISTER:**

The names of the members to whom the decoration or bar is awarded, shall be published in a national distribution list and shall, together with a copy of the certificate of award in respect of each decoration or medal which was awarded to a person in terms of the Regulations, be forwarded to the office of the National Commissioner for purposes of filing such certificate of award and making an entry in a register for the awarding of medals and decorations by Municipal/Metropolitan Police Services for record keeping purposes.

**11. WEARING OF THE DECORATION:**

The decoration shall be worn on the left breast and a bar in respect thereof, shall be affixed to the ribbon. When the decoration is not worn, only the ribbon in respect thereof shall be worn on the left breast, and where a bar has been awarded, a device in the form of a silver gilt five-pointed star, with a diameter of 10mm, shall be affixed to the ribbon as an indication of the award of each such bar.

**12. ENTITLEMENT:**

The award of the decoration or bar shall not entitle the recipient to any individual precedence, but shall allow him or her to add the letters "MPBG", derived from the initial letters of the name of the award, after his or her name.


**13. DECORATION IN MINIATURE:**

**14. SEALED MODEL OF DECORATION:**



Whereas it is deemed desirable to recognize acts of bravery displayed by members of Municipal/Metropolitan Police Services who, in the discharge of their functions or in protecting or saving property or life, have lost or imperilled their own lives;

And whereas it is deemed expedient to honour such members in a fitting manner;

Now, therefore, by virtue of the powers granted to me to confer honours in accordance with the provisions of *Section 84(2) of the Constitution of the Republic of South Africa, 1996, read together with Sections 44(2) & 640 of the South African Police Service Act, 1995 (Act No. 68 of 1995), Regulation 9 (Annexure 5) of the Regulations for Municipal Police Services as promulgated in Government Gazette No. 20142 dated 11 June 1999 and the Regulations for Municipal (Metropolitan) Police Services regarding Medals and Decorations as promulgated in Government Gazette No. 30523 dated 4 December 2007*, I do hereby institute a new decoration in recognition of acts of bravery by members of Municipal Police Services, and further ordain that the following Rules as may be made under this Warrant, shall govern the award of this decoration:

**1. PRECEDENCE:**

In respect of decorations or medals awarded exclusively to members of Municipal/Metropolitan Police Services, the decoration shall take precedence immediately after the Municipal/Metropolitan Police Service Gold Cross for Bravery, and also holds the position in the official table of precedence, as determined by the Presidency from time to time.

**2. DESCRIPTION:**

Obverse: The decoration shall be in the form of a silver cross paty nowy, charged in the centre with a blue roundel, thereupon, a full laurel wreath surrounding a five pointed faceted star, all silver.

Reverse: The national coat of arms of the Republic of South Africa, and there above, the semi circular inscription, FORTES FORTUNA JUVAT.

Size: 40mm across.

Suspension: Pendant from a plain suspender fixed to the upper arm of the cross and hanging from a breast ribbon.

**3. RIBBON:**

The Municipal/Metropolitan Police Service Silver Cross for Bravery shall be pendant from a ribbon 32 mm wide: 2mm red, 2mm white, 10mm blue, 4mm white, 10mm blue, 2mm white and 2mm red.

**4. BAR:**

A bar may be awarded in terms of rule 6, and shall be of silver 6mm wide and 34mm in length bearing a five-pointed faceted silver star with a diameter of 10 mm. For each subsequent award, the bar shall bear an additional five-pointed faceted silver star.

**5. CONFERMENT REQUIREMENTS DECORATION:**

A declaration may be awarded to a member of a Municipal/Metropolitan Police Service who has distinguished himself or herself by performing a deed of bravery in dangerous circumstances.

**6. CONFERMENT REQUIREMENTS BAR:**

A bar may be awarded to any member of a Municipal/Metropolitan Police Service to whom this decoration has already been awarded and who, subsequent to such award and while still serving as a member of a Municipal/Metropolitan Police Service, has again distinguished himself or herself in the manner described in rule 5.

In respect of every such additional distinction, a bar may be awarded: Provided that a bar shall be awarded only to a member who is already in possession of the decoration. Otherwise an appropriate decoration shall be awarded and not a bar.

**7. CONFERMENT, FORFEITURE OR RESTORATION OF DECORATION:**

The decoration, as well as the bar in respect thereof, shall be awarded by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of a Municipal/Metropolitan Police Service, and may also be cancelled, annulled, declared forfeited or restored by the Mayor of the Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, subject to such conditions as may be prescribed by the Regulations.



- Reverse: The national coat of arms of the Republic of South Africa, and there above, the semi circular inscription, VIRTUTE ET FIDE.
- Size: 38mm in diameter.
- Composition: Silver gilt, with blue enamel.
- Suspension: Pendant from a plain suspender fixed to the upper rim and hanging from a breast ribbon.

**3. RIBBON:**

The Municipal/Metropolitan Police Service Gold Decoration for Outstanding Service shall be a pendant from a ribbon 32mm wide: 3mm blue, 2mm white, 2mm blue, 2mm gold, 14mm green, 2mm gold, 2mm blue, 2mm white, 3mm blue.



Now, therefore, by virtue of the powers granted to me to confer honours in accordance with the provisions of *Section 84(2) of the Constitution of the Republic of South Africa, 1996, read together with Sections 44(2) & 64O of the South African Police Service Act, 1995 (Act No. 68 of 1995), Regulation 9 (Annexure 5) of the Regulations for Municipal Police Services as promulgated in Government Gazette No. 20142 dated 11 June 1999 and the Regulations for Municipal (Metropolitan) Police Services regarding Medals and Decorations as promulgated in Government Gazette No. 30523 dated 4 December 2007*, I do hereby institute a new medal in recognition of commendable service rendered by members of Municipal/Metropolitan Police Service or other persons in support of the Municipal/Metropolitan Police Service, and further ordain that the following Rules as may be made under this Warrant, shall govern the award of the medal:

**1. PRECEDENCE:**

In respect of decorations or medals which may be awarded to members of a Municipal/Metropolitan Police Service, the medal shall take precedence immediately after the Municipal (Metropolitan) Police Service Silver Decoration for Outstanding Service, and also holds the position in the official table of precedence, as determined by the Presidency from time to time.

**2. DESCRIPTION:**

- Obverse: The medal shall be octagonal, charged in the centre on a blue roundel, with sixteen rays issuant, with a full laurel wreath surrounding a five-pointed faceted star.
- Reverse: The national coat of arms of the Republic of South Africa.
- Size: Octagonal, fitting within a circle with a diameter of 40 mm.
- Composition: Cupro-nickel and blue enamel.
- Suspension: Pendant from a plain suspender fixed to the upper rim and hanging from a breast ribbon.

**3. RIBBON:**

The Municipal/Metropolitan Police Service Commendation Medal shall be pendant from a ribbon 32mm wide: 10mm blue, 4mm white, 4mm green, 4mm white, 10mm blue.

**4. BAR:**

A bar may be awarded in terms of rule 6, and shall be of cupro-nickel measuring 34mm in length and 6mm wide, bearing a five-pointed faceted cupro-nickel star with a diameter of 10mm.

For each subsequent award, the bar shall bear an additional five-pointed faceted cupro-nickel star.

**5. CONFERMENT REQUIREMENTS MEDAL:**

A medal may be awarded to a member of a Municipal/Metropolitan Police Service or any other person who has distinguished himself or herself by rendering commendable services of a meritorious nature, or distinguished himself or herself through outstanding resourcefulness and sense of duty and by setting an example in any branch of the Municipal/Metropolitan Police Service.

**6. CONFERMENT REQUIREMENTS BAR:**

A bar may be awarded to any member of a Municipal/Metropolitan Police Service or any other person to whom the medal has already been awarded and who, subsequent to such award has again distinguished himself or herself in the manner described in rule 5. In respect of every such subsequent distinction, an additional bar may be awarded: Provided that a bar shall be awarded only to a member or person who is already in possession of the medal.

**7. CONFERMENT, FORFEITURE OR RESTORATION OF MEDAL:**

Reverse: The national coat of arms of the Republic of South Africa.

Size: 38mm in diameter.

Composition: Sterling Silver.

Suspension: Pendant from a plain suspender fixed to the upper rim and hanging from a breast ribbon.

**3. RIBBON:**

Municipal/Metropolitan Police Service 20 Year Loyal Service Medal shall be a pendant from a ribbon 32mm wide: 9mm blue, 2mm white, 4mm red, 2mm white, 4mm red, 2mm white, 9mm blue.

**4. CONFERMENT REQUIREMENTS:**

The Municipal/Metropolitan Police Service Twenty Year Loyal Service Medal may be awarded to a member of the respective Municipal/Metropolitan Police Services, who has served for a period of at least 20 years (not necessarily continuous) and has displayed an irreproachable character and exemplary conduct.

**5. SERVICE QUALIFICATIONS:**

The following service, which may have been interrupted, may be regarded as qualifying service for the award of the medal: Provided that evidence is submitted of all service to be recognized to the satisfaction of the National Forum of the Chiefs of Municipal/Metropolitan Police Services.

Service as a member of the —

1. Municipal/Metropolitan Police established in terms of the South African Police Service Act, 1995 (Act No. 68 of 1995);
2. City Police, Traffic Service, Security Service or Law Enforcement Agency of a local authority that established a Municipal Police Service referred to in paragraph 1;
3. South African Police or South African Police Service (full time);
4. Provincial Traffic Service of the provinces of the Republic of South Africa or similar institutions of the erstwhile Transkei, Ciskei, Bophuthatswana or Venda before 29 January 1995;
5. Permanent Force of the South African Defense Force or the South African National Defense Force;
6. South African Prison Service or South African Correctional Services (full time);
7. Azanian People's Liberation Army or Umkhonto we Sizwe before 27 April 1994: Provided that the member's name appears either in the Name Lists or in the certified personnel registers of the institutions concerned and an appropriate authenticated service certificate appears on the members file, or is submitted;
8. Police Service, Defense Force or Correctional Services or similar institutions of the erstwhile Transkei, Ciskei, Bophuthatswana, Venda, or Service as a member of the police services or correctional services or similar institutions of the self-governing Territories before 29 January 1995;
9. Reserves of the South African Police or forces mentioned in paragraph 8 before 29 January 1995: Provided that service rendered between 29 January 1995 and 15 October 1995 may be recognized only for those years during which the member served in any manner for at least 12 days, which service may have been continuous or non continuous and irrespective whether the member was remunerated or not; or
10. Municipal Police, which integrated into the former South African Police on 1 October 1989, which service, was rendered before 29 January 1995.

**6. CONFERMENT, FORFEITURE OR RESTORATION OF MEDAL:**

The medal shall be awarded by the Mayor of the Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, and may also be cancelled, annulled, declared forfeited or restored by the Mayor of the Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, subject to such conditions as may be prescribed by the Regulations

**7. POSTHUMOUS AWARD:**

The medal may be awarded posthumously.

**8. ENGRAVING OR STAMPING OF SERIAL NUMBER:**

On the reverse of each medal awarded shall be engraved or stamped a serial number that is linked to the service number of the recipient.

**9. PUBLICATION IN DISTRIBUTION LIST & RECORDING IN REGISTER:**

The names of the members to whom the medal is awarded, shall be published in a national distribution list and shall together with a copy of the certificate of award in respect of each decoration or medal which was awarded to a person in terms of the Regulations be forwarded to the office of the National Commissioner for purposes of filing such certificate of award and making an entry in a register for the awarding of medals and decorations by Municipal/Metropolitan Police Services for record keeping purposes.

**10. WEARING OF THE MEDAL:**

The medal shall be worn on the left breast. When the medal is not worn, only the ribbon in respect thereof shall be worn on the left breast.

**11. ENTITLEMENT:**

The award of the medal shall not entitle the recipient to any individual precedence.





**Greetings!**

Whereas it is deemed desirable to recognize long and loyal service rendered by members of Municipal/Metropolitan Police Services;

And whereas it is deemed expedient to honour such members in a fitting manner;

Now, therefore, by virtue of the powers granted to me to confer honours in accordance with the provisions of *Section 84(2) of the Constitution of the Republic of South Africa, 1996, read together with Sections 44(2) & 64O of the South African Police Service Act, 1995 (Act No. 68 of 1995), Regulation 9 (Annexure 5) of the Regulations for Municipal Police Services as promulgated in Government Gazette No. 20142 dated 11 June 1999 and the Regulations for Municipal (Metropolitan) Police Services regarding Medals and Decorations as promulgated in Government Gazette No. 30523 dated 4 December 2007*, I do hereby institute a new medal in recognition of exceptional devotion to duty by members of Municipal/Metropolitan Police Services, and further ordain that the following Rules as may be made under this Warrant, shall govern the award of this decoration:

**1. PRECEDENCE:**

In respect of decorations or medals which may be awarded exclusively to members of a Municipal/Metropolitan Police Service, the medal shall take precedence immediately after the Municipal/Metropolitan Police Service 20 Year Loyal Service Medal, and also holds the position in the official table of precedence, as determined by the Presidency from time to time.

**2. DESCRIPTION:****10-Year Loyal Service:**

Obverse: The medal shall be circular, bearing within a full laurel wreath, a five-pointed faceted star.

Reverse: The national coat of arms of the Republic of South Africa.

Size: 38mm in diameter.

<u>Composition:</u>	Bronze.
<u>Suspension:</u>	Pendant from a plain suspender fixed to the upper rim and hanging from a breast ribbon.

### **3. RIBBON:**

Municipal/Metropolitan Police Service 10 Year Loyal Service Medal shall be a pendant from a ribbon 32mm wide: 12mm blue, 2mm white, 4mm red, 2mm white, 12mm blue.

### **4. CONFERMENT REQUIREMENTS:**

The Municipal/Metropolitan Police Service Ten Year Loyal Service Medal may be awarded to a member of the respective Municipal/Metropolitan Police Services who has served for a period of at least 10 years (not necessarily continuous) and has displayed an irreproachable character and exemplary conduct.

### **5. SERVICE QUALIFICATIONS:**

The following service, which may have been interrupted, may be regarded as qualifying service for the award of the medal: Provided that evidence is submitted of all service to be recognized to the satisfaction of the National Forum of the Chiefs of Municipal/Metropolitan Police Services.

Service as a member of the

1. Municipal/Metropolitan Police Service established in terms of the South African Police Service Act, 1995 (Act No. 68 of 1995).
2. City Police, Traffic Service, Security Service or Law Enforcement Agency of a local authority that established a Municipal Police Service referred to in paragraph 1.
3. South African Police or South African Police Service (full time).
4. Provincial Traffic Service of the provinces of the Republic of South Africa or similar institutions of the erstwhile Transkei, Ciskei, Bophuthatswana or Venda before 29 January 1995.
5. Permanent Force of the South African Defense Force or the South African National Defense Force.
6. South African Prison Service or the South African Correctional Service (full time).
7. Azanian People's Liberation Army or Umkhonto we Sizwe before 27 April 1994: Provided that the member's name appears either in the Name Lists or in the certified personnel registers of the institutions concerned and an appropriate authenticated service certificate appears on the members file, or is submitted.
8. Police Service, Defense Force or Correctional Services or similar institutions of the erstwhile Transkei, Ciskei, Bophuthatswana, Venda, or Service as a member of the police services or correctional services or similar institutions of the self-governing Territories before 29 January 1995.
9. Reserves of the South African Police or forces mentioned in paragraph 8 before 29 January 1995: Provided that service rendered between 29 January 1995 and 15 October 1995 may be recognized only for those years during which the member served in any manner for at least 12 days, which service may have been continuous or non continuous and irrespective whether the member was remunerated or not.

10. Municipal Police, which integrated into the former South African Police on 1 October 1989, which service, was rendered before 29 January 1995.

**6. CONFERMENT, FORFEITURE OR RESTORATION OF MEDAL:**

The medal shall be awarded by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of a Municipal/Metropolitan Police Service, and may also be cancelled, annulled, declared forfeited or restored by the Mayor of the Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, subject to such conditions as may be prescribed by the Regulations

**To all to whom these presents may come:**

**Greetings!**

Whereas it is deemed desirable to recognize signal acts of valour displayed by dogs and horses of Municipal/Metropolitan Police Services who, in the discharge of their functions or in protecting or saving property or life, have lost or genuinely imperilled their own lives;

And whereas it is deemed expedient to honour such animals in a fitting manner;

Now, therefore, by virtue of the powers granted to me to confer honours in accordance with the provisions of *Section 84(2) of the Constitution of the Republic of South Africa, 1996, read together with Sections 44(2) & 64O of the South African Police Service Act, 1995 (Act No. 68 of 1995), Regulation 9 (Annexure 5) of the Regulations for Municipal Police Services as promulgated in Government Gazette No. 20142 dated 11 June 1999 and the Regulations for Municipal (Metropolitan) Police Services as promulgated in Government Gazette No. 30523 dated 4 December 2007*, I do hereby institute a new decoration in recognition of acts of bravery by dogs and horses of Municipal/Metropolitan Police Services, and further ordain that the following Rules as may be made under this Warrant, shall govern the award of this decoration:

**1. PRECEDENCE:**

In respect of decorations or medals which may be awarded exclusively to service animals of Municipal/Metropolitan Police Services, the decoration shall take precedence immediately after the Municipal/Metropolitan Police Service 10 Year Loyal Service Medal, and also holds the position in the official table of precedence, as determined by the Presidency from time to time.

**2. DESCRIPTION:****Canine and Equine Cross for Bravery:**

Obverse: On a gold cross paty, another of purple, charged in the centre, within an inverted horseshoe with the head and neck of a German Shepherd dog in half profile, both gold.

Reverse: The national coat of arms of the Republic of South Africa, there above, the semi circular inscription, FORTES FORTUNA JUVAT.

Size: 40mm across.

Composition: Silver gilt and purple enamel.

Suspension: Pendant from a ring attached to the upper arm, attached to the necklet ribbon joined in the form of a "V" and passing around the neck of the recipient animal.

Bar A clasp 8mm wide charged in the centre with an inverted horseshoe, there within the head and neck of a German Shepherd dog, all gold.

### **3. RIBBON:**

The Municipal/Metropolitan Police Service Canine and Equine Cross for Bravery shall be a pendant from a ribbon 35mm wide: 5.5mm red, 5.5mm white, 5.5mm blue, 2mm yellow, 5.5 blue, 5.5mm white, 5.5mm red.

### **4. BAR:**

The bar to the medal, which may be awarded in terms of rule 6, shall be as described under rule 2 above.

### **5. CONFERMENT REQUIREMENTS:**

The Municipal/Metropolitan Police Service Canine and Equine Cross for Bravery may be awarded to a dog or horse in the service of a Municipal/Metropolitan Police Service that has distinguished itself by performing a signal deed of bravery in dangerous circumstances.

### **6. CONFERMENT REQUIREMENTS RELATING TO A BAR:**

A bar may be awarded to any dog or horse in the service of the Municipal/Metropolitan Police Service to which the decoration has already been awarded and that, subsequent to such award and while still serving in the Municipal/Metropolitan Police Service, has again distinguished itself in the manner described in rule 5. In respect of every such additional distinction, an additional bar may be awarded.

### **7. CONFERMENT, FORFEITURE OR RESTORATION OF MEDAL:**

The medal, as well as the bar in respect thereof, shall be awarded by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of a Municipal/Metropolitan Police Service and may also be cancelled, annulled, declared forfeited or restored by the Mayor of a Municipal/Metropolitan Council upon the recommendation of the Executive Head of the Municipal/Metropolitan Police Service, subject to such conditions as may be prescribed by the Regulations

### **8. POSTHUMOUS AWARD:**

The medal may be awarded posthumously.

**9. ENGRAVING OR STAMPING OF SERIAL NUMBER:**

On the reverse of each medal awarded shall be engraved or stamped a serial number that is linked to the service number of the animal.

**10. PUBLICATION IN DISTRIBUTION LIST & RECORDING IN REGISTER:**

The names of the animals to which the medals are awarded together with the names of the handlers or riders at the time of the 'signal act of bravery', shall be published in a national distribution list and shall, together with a copy of the certificate of award in respect of each decoration or medal which was awarded to a dog or horse in terms of the Regulations, be forwarded to the office of the National Commissioner for purposes of filing such certificate of award and making an entry in a register for the awarding of medals and decorations by Municipal/Metropolitan Police Services for record keeping purposes.

**11. WEARING OF THE MEDAL:**

The medal shall be worn around the neck of the animal, and where a bar has been awarded; the bar shall be affixed to the ribbon as an indication of the award of such bar.

**12. SEALED MODEL OF MEDAL:**


